## ROAD TRAFFIC REGULATION ACT 1967

*The East Sussex (Roads at Seven Dials, Brighton/Hove) (Prohibition of Waiting and One-Way Traffic) Order 1977*

Notice is hereby given that East Sussex County Council have made an Order under sections 1 and 84D (1) of the Road Traffic Regulation Act 1967, as amended.

The effect of the Order on roads at Seven Dials, Brighton/Hove is from 1st September 1977:

- (a) to prohibit waiting at any time in the following roads:  
Bath Street,  
Dyke Road (40 metres (44 yards) length at its junction with Seven Dials),  
Goldsmid Road (40 metres (44 yards) length at its junction with Seven Dials).
- (b) to make the following lengths of roads one-way:

## Length of Road and Direction of Traffic Flow

Bath Street, between Buckingham Place and Dyke Road, south-westwards.

Buckingham Place, between Bath Street and Seven Dials, eastwards.

Dyke Road, between Bath Street and Seven Dials, north-westwards.

Exceptions have been included in the Order as follows:

- (i) in the case of (a) above in respect of disabled persons' vehicles and to permit picking up and setting down passengers, loading and unloading goods, the maintenance of the roads and the services therein; and  
(ii) in the case of (b) above in respect of any mechanical road cleansing vehicle between the hours of 6 a.m. and 10 p.m.

A copy of the Order, together with a plan showing the lengths of roads concerned, may be examined at my office between the hours of 9 a.m. and 4.30 p.m. on Monday to Friday inclusive until 11th October 1977. Any person who desires to question the validity of the Order or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may, within 6 weeks from 30th August 1977 apply to the High Court for this purpose.

## SWANSEA CITY COUNCIL

*The Swansea City Council (Off-Street Parking Places) (Pay and Display) Order 1977*

Notice is hereby given in accordance with the provisions of section 84C of the Road Traffic Regulation Act 1967 and the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1969 that the Swansea City Council propose to make an Order providing for the use of parking places in the City Centre Area specified in the Schedule to this Notice. In particular the Order will provide as to the vehicles or classes of vehicles entitled to use each parking place, the conditions of use and the charges to be paid in connection therewith, as specified in the Schedule. The collection of charges in each parking place will be by parking ticket machine and failure to comply with the provisions of the Order will result in an excess charge of two pounds payable by the driver of a parked vehicle.
