The Secretary of State for Wales hereby gives notice that he proposes to make the following Orders:

1. An Order under section 7 of the Highways Act 1959 providing that roads about 244 metres and 172 metres in length which he proposes to construct at Black Bridge, Llandinam in the county of Powys shall become trunk roads as from the date when the Order comes into operation, and
2. An Order under section 9 of the Highways Act 1959 authorising him:
 - (a) to improve, raise, lower or otherwise alter highways,
 - (b) to stop up highways,
 - (c) to construct new highways,
 - (d) to stop up private means of access to premises, and
 - (e) to provide new means of access to premises,

all at Black Bridge, Llandinam aforesaid and providing for the transfer of each of the said new highways to the County Council of Powys as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.

Copies of the draft Orders and of the relevant plans may be inspected free of charge at all reasonable hours from 6th September 1977 to 24th October 1977 at the Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff and at the offices of Powys County Council, Powys County Hall, Llandrindod Wells, Powys County Council, Area Office, The Park, Newtown and at the Post Office, Llandinam.
