HIGHWAYS ACTS 1959 TO 1971

The Caersws-Machynlleth Trunk Road (Bryn-y-Llys, Pontdolgoch Diversion) Order 1977

and

The Caersws-Machynlleth Trunk Road (Bryn-y-Llys, Pontdolgoch Diversion Side Roads) Order 1977

The Secretary of State for Wales hereby gives Notice that in relation to the above mentioned Trunk Road at Bryn-y-Llys, Pontdolgoch in the county of Powys, he has made under the Highways Act 1959:

1. An Order under section 7 which provides:

- (a) that a road about 100 metres in length which he proposes to construct at Bryn-y-Llys, Pontdolgoch near Caersws in the county of Powys shall become a trunk road as from the date when the Order comes into operation, and
- (b) that the length of the Caersws-Machynlleth Trunk Road to be superseded shall cease to be a trunk road as from the date on which notice is given by him to the County Council of Powys that the new trunk road is open for through traffic, and

2. An Order under section 9 of the Highways Act 1959 authorising him to stop up a part of the Caersws-Machynlleth Trunk Road which will be superseded by the construction of the said road at Bryn-y-Llys, Pontdolgoch.
