Provided that in the said Graveyard, in any grave space in which no interment has heretofore taken place, the burial may be allowed of the body of any person for whom or of any member of a family for which such grave space has been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the grave

depth less than three feet below the level of the surface of the ground adjoining the grave. Now, therefore, Her Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 21st day of November next. And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the churches or chargels of or on some counsiderations places within the

or chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 21st day of November.
