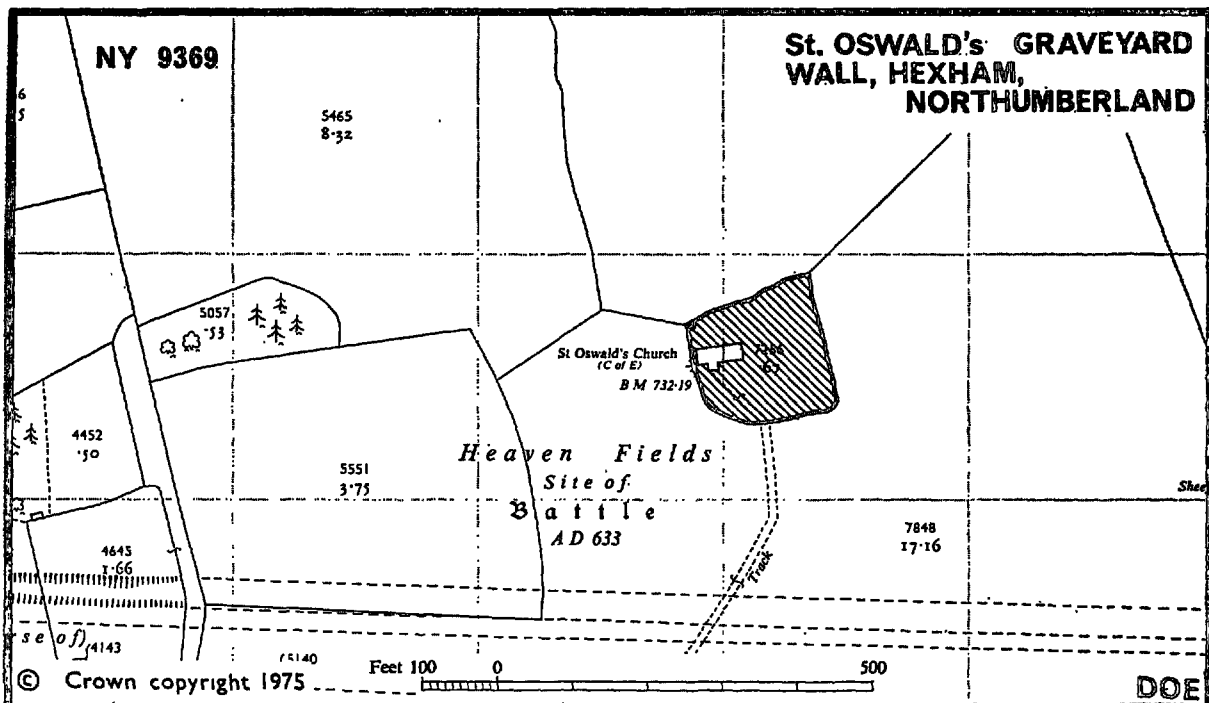


The Plan referred to in the foregoing Order in Council



PASTORAL MEASURE 1968

18th October 1977.

Notice is hereby given that Her Majesty was pleased on the 11th October 1977 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Providing for the Redundant Churches Fund to be responsible for the care and maintenance of the redundant parish church of the former parish of Cowthorpe, in the diocese of Ripon.
2. Uniting the benefices of Haynford and Stratton Strawless, in the diocese of Norwich.
3. Uniting the benefices of Goldthorpe and Hickleton, in the diocese of Sheffield.
4. Uniting the benefices and parishes of Whitfield; and Ninebanks and Carrshield, in the diocese of Newcastle.
5. Uniting the benefices of Bradford Peverell with Stratton; Frampton; and Sydling Saint Nicholas, in the diocese of Salisbury.
6. Providing for the demolition of the redundant parish church of the former parish of Christ Church Dukinfield in the diocese of Chester and empowering the said Commissioners to sell its site and the land annexed or belonging thereto.
7. Uniting the benefices of Chevington with Hargrave; and Whepstead with Brockley, in the diocese of Saint Edmundsbury and Ipswich.
8. Appropriating part of the churchyard of the parish church of the parish of Christ Church, Southport, in the diocese of Liverpool, for parochial purposes.
9. Vesting part of the churchyard of the parish church of the parish of Abbots Langley, in the diocese of Saint Albans, in the Saint Albans Diocesan Board of Finance for disposal.
10. Uniting the benefices and parishes of Poplar and Saint Matthias, Poplar, in the diocese of London, and declaring redundant the parish church of the parish of Saint Matthias, Poplar.
11. Uniting the benefices of Trunch with Swafeld, Antingham with Thorpe Market, Bradfield, Gimmingham, Southrepps, and Trimmingham, in the diocese of Norwich, and for establishing a team ministry for the area of the new benefice.
12. Uniting the benefices and parishes of Saint Nicholas, Dunston; and Christ Church, Dunston, in the diocese of Durham.
13. Uniting the parishes of Aldborough and Thurgarton, in the diocese of Norwich; and declaring redundant the parish church of the parish of Thurgarton.
14. Uniting the parishes of Iwerne Courtney; and Step-leton Iwerne, in the diocese of Salisbury.
15. Uniting the benefices of Brampton Ash with Dingley; and Braybrooke, in the diocese of Peterborough; and for holding the new benefice in plurality with the benefice of Desborough.
16. Uniting the benefices and parishes of Barnburgh and Melton on the Hill, in the diocese of Sheffield.
17. Declaring redundant the church of Christ Church, Scarborough, a chapel of ease in the parish of Saint Mary with Christ Church, Saint Paul and Saint Thomas, Scarborough, in the diocese of York and altering the name of the said parish and the existing benefice of the same name.
18. Providing for the demolition of the redundant church of All Saints, St. John's Wood, in the diocese of London, and empowering the said Commissioners to sell or lease its site and the land annexed or belonging thereto.
19. (1) Providing for a new place of worship within the parish of Saint Mary, Ince-in-Makerfield, in the diocese of Liverpool, (2) declaring redundant the existing parish church of the said parish and (3) authorising the demolition of the existing parish church and the disposal of its site, and the land annexed or belonging thereto.
20. Appropriating part of a detached burial ground within the parish of Whitwood, in the diocese of Wakefield, as glebe of the benefice of Whitwood.
21. Providing for the Redundant Churches Fund to be responsible for the care and maintenance of the redundant parish church of the former parish of All Saints, Conington, in the diocese of Ely.
22. Appropriating the redundant parish church of the former parish of Christ Church and Holy Trinity, Derby, in the diocese of Derby, to use for religious activities in accordance with the rites and customs of the Serbian Orthodox Church and for purposes ancillary thereto, and empowering the said Commissioners to sell the said Building and the land annexed or belonging thereto for such uses.
23. Uniting the benefices and parishes of Saint Alban, Trimdon Grange; and Deaf Hill cum Langdale, in the diocese of Durham.
24. Appropriating the redundant parish church of the former parish of Horrington, in the diocese of Bath and Wells, to use for residential purposes and for purposes
