

## PASTORAL MEASURE 1968

Notice is hereby given that on the 25th day of October 1977, Her Majesty Queen Elizabeth The Queen Mother and His Royal Highness The Duke of Gloucester as Counsellors of State, by Order in Council on Her Majesty's behalf confirmed the following Schemes made by the Church Commissioners for:

1. Uniting the benefices and parishes of East Tilbury and West Tilbury, and altering the areas of the new parish and the parish of Saint John the Baptist, Tilbury Docks, in the diocese of Chelmsford.

2. Creating a new benefice and parish of Aylesham out of part of the existing parish of Nonington, and altering the areas of the parishes of Adisham; Bekesbourne; Ickham; Kingston; Patribourne with Bridge and Wymynswold, in the diocese of Canterbury.

3. Uniting the benefices of Wethersfield and Shalford, in the diocese of Chelmsford.

4. Uniting the benefices of Mark and Allerton, in the diocese of Bath and Wells.

5. Uniting the benefices of Cleeve Prior; and South Littleton with North and Middle Littleton, in the diocese of Worcester.

6. Uniting the benefices and parishes of Saint Stephen with Saint Philip and Saint Ann, Sheffield; and Saint Bartholomew, Langsett Road; (2) establishing a team ministry for the area of the new benefice; and (3) altering the areas of the new parish and the parish of Saint George, Sheffield, in the diocese of Sheffield.

7. Uniting the benefices of Raveningham, Aldeby with Wheatacre with Burgh Saint Peter; Haddiscoe with Toft Monks; Hales with Heckingham; Norton Subcourse; and Thurlton with Thorpe, in the diocese of Norwich, and establishing a team ministry for the area of the new benefice.
