DEPARTMENT OF TRANSPORT

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that on the application of the Langbaugh Borough Council, he proposes to make an Order under section 121 of the above Act to provide for the extinguishment of any right which persons may have to use vehicles on lengths of Fawcus Road, Adshead Road, Ramsey Road and Westfield Way, Dormanstown, Cleveland.

The proposed Order will contain provisions for permitting the use of those highways by vehicles being used:

- (a) for police, ambulance or fire brigade purposes;
- (b) on behalf of a statutory undertaker or the Post Office and engaged upon the laying, erection, inspection, maintenance, alteration, repair, renewal or removal under, in, on, over, along or across the highway of any main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or of any telegraph line as defined in the Telegraph Act 1878.

The proposed Order will require the provision of new highways maintainable at the public expense, for which the highway authority is to be Cleveland County Council.

During 28 days from the 17th November 1977, copies of the draft Order and relevant plan may be inspected at the offices of the Regional Controller (Roads and Transportation), Northern Region, Room 703, Wellbar House, Gallowgate, Newcastle upon Tyne, NE1 4TD; at the address of the Borough Secretary, Langbaugh Borough Council, Langbaugh Town Hall, Fabian Road, Middlesbrough; and at the Redcar Information Centre, Municipal Buildings, Coatham Road, Redcar, and may be obtained free of charge from the Secretary of State (quoting DN504735/15) at the address stated below.
