

(ii) on waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place would be changed so that such prohibition would apply between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the length of Elder Avenue specified in Schedule 2 to this notice;

(c) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited:—

(i) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 4 to this notice and in the first 60 feet of adjacent Harold Road, Harvey Road and Rokesly Avenue;

(ii) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of Tottenham Lane specified in Schedule 5 to this notice and in the first 60 feet of adjacent Inderwick Road, Montague Road and Nelson Road;

(d) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place would be prohibited:—

(i) between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets referred to in sub-paragraph (c) (i) above;

(ii) between 11 a.m. and 4.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets referred to in sub-paragraph (c) (ii) above;

(e) the sale or offer for sale of goods from a vehicle in the lengths of streets referred to in sub-paragraph (c) above would be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Haringey Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;

(f) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, in the lengths of streets referred to in sub-paragraph (c) above would be prohibited.

4. The prohibitions referred to in paragraph 3 (c) and (d) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" would delay.

A copy of each of the proposed Orders, of the above-mentioned Order of 1972, of the Haringey (Waiting and Loading Restriction) Order 1971 (and of the Orders which have amended that Order), and of the Council's statement of reasons for proposing to make the Orders can be inspected during normal office hours on Mondays to Fridays inclusive until 4th January 1978 in Room B.21, The County Hall, London, SE1 7PB.

SCHEDULE 1

Elder Avenue, between the north-western kerb-line of Tottenham Lane and a point 60 feet north-west of that kerb-line.

Rosebery Gardens, the south-west side, between the north-western kerb-line of Tottenham Lane and a point 60 feet north-west of that kerb-line.

Tottenham Lane, the north-west side, between a point opposite the party wall of Nos. 1 and 2 Broadway Parade, Tottenham Lane and the south-western kerb-line of Rosebery Gardens.

SCHEDULE 2

Elder Avenue, between the south-eastern kerb-line of Tottenham Lane and a point 60 feet south-east of that kerb-line.

SCHEDULE 3

Tottenham Lane, the south-east side

(a) between a point opposite the party wall of Nos. 14 and 15 Broadway Parade, Tottenham Lane and a point 51 feet south-west of that point;

(b) between a point opposite the party wall of Nos. 24 and 25 Broadway Parade, Tottenham Lane and a point 51 feet south-west of that point;

(c) between a point opposite the party wall of Nos. 32 and 33 Broadway Parade, Tottenham Lane and a point 51 feet south-west of that point.

SCHEDULE 4

Church Lane, Hornsey, the north-west side, between its junction with Tottenham Lane and a point opposite the party wall of Nos. 2 and 3 Church Lane, Hornsey including the carriageway immediately adjacent to the north-west and south-west sides of the island site situated at the junction of Church Lane, Hornsey and Tottenham Lane.

Elder Avenue, between a point 60 feet south-east of the south-eastern kerb-line of Tottenham Lane and a point opposite the south-eastern boundary of No. 26 Broadway Parade, Tottenham Lane.

Elmfield Avenue, between the north-western kerb-line of Tottenham Lane and a point 76 feet north-west of that kerb-line.

Ferne Park Road, between the south-eastern kerb-line of Tottenham Lane and a point 60 feet south-east of that kerb-line.

Tottenham Lane

(a) the north-west side

(i) between a point 105 feet south-west of the south-western kerb-line of Elmfield Avenue and a point opposite the party wall of Nos. 121 and 123 Tottenham Lane;

(ii) between a point 70 feet north-east of the north-eastern kerb-line of Inderwick Road and its junction with Church Lane, Hornsey;

(b) the south-east side

(i) between a point 5 feet south-west of a point opposite the south-western wall of Nos. 157 Tottenham Lane and a point opposite the party wall of Nos. 121 and 123 Tottenham Lane;

(ii) between a point opposite the party wall of Nos. 61 and 63 Tottenham Lane and the south-western kerb-line of Rathcoole Avenue.

SCHEDULE 5

Tottenham Lane

(a) the north-west side

(i) between a point 18 feet north-east of the north-eastern kerb-line of Rosebery Gardens and a point 105 feet south-west of the south-western kerb-line of Elmfield Avenue;

(ii) between a point opposite the party wall of Nos. 121 and 123 Tottenham Lane and a point 70 feet north-east of the north-eastern kerb-line of Inderwick Road;

(b) the south-east side

(i) between a point opposite the party wall of Nos. 32 and 33 Broadway Parade, Tottenham Lane and a point 5 feet south-west of a point opposite the south-western wall of No. 157 Tottenham Lane;
