**ROAD TRAFFIC REGULATION ACT, 1967**

*The Staffordshire County Council (Mount Street, Stone D.407) (Prohibition of Waiting) Order 1977*

Notice is hereby given that the Staffordshire County Council on 12th December 1977 made an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act, 1972, and Schedule 6 to the Road Traffic Act, 1974.

This Order means that you are not allowed to leave your vehicle at any time on the lengths of road specified in the Schedule to this notice.

Exceptions permit waiting for the purposes of taking up and setting down of passengers, loading or unloading goods, for vehicles displaying a Disabled Person's badge, and where necessary in connection with the maintenance of roads and the supply of gas, electricity and water.

Full details are in the Order which together with a map showing the restricted areas may be examined during normal office hours at my office and at the Stone Branch of the County Library, High Street, Stone.

Any person who desires to question the validity of the Order or any provision contained in the Order on the grounds that it is not within the powers of the relevant sections of the Road Traffic Regulation Act, 1967, as amended or on the grounds that any requirement of those sections or of sections 84A, 84B or 84C of the Act, or any regulations made under the said section 84C has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

The Order will come into operation on 21st December 1977.

**SCHEDULE 1**

*(One-Way Traffic)*

*Lengths of Road in the Borough of Stafford and Direction Permitted*

1. *Austin Friars, Stafford*, between its junctions with Friars Terrace and Wolverhampton Road. From its junction with Friars Terrace to its junction with Wolverhampton Road.

2. *Garden Street, Stafford*, between its junctions with Wolverhampton Road and Cramer Street. From its junction with Wolverhampton Road to its junction with Cramer Street.

3. *Meyrick Road, Stafford*, between its junctions with Wolverhampton Road and Salt Road. From its junction with Wolverhampton Road to its junction with Salt Road.

4. *Park Street, Stafford*, between its junctions with Wolverhampton Road and Friars Terrace. From its junction with Wolverhampton Road to its junction with Friars Terrace.

5. *Salt Road, Stafford*, between its junctions with Meyrick Road and Salt Avenue. From its junction with Meyrick Road to its junction with Salt Avenue.

6. *Talbot Road, Stafford*, between its junctions with Salt Road and Wolverhampton Road. From its junction with Salt Road to its junction with Wolverhampton Road.

7. *Telegraph Street, Stafford*, between its junctions with Wolverhampton Road and Austin Friars. From its junction with Wolverhampton Road to its junction with Austin Friars.

**SCHEDULE 2**

*(Prohibition of Driving except for access)*

*Lengths of Road in the Borough of Stafford*

1. *Friars Walk, Stafford*, between its junctions with Friars Terrace and Bailey Street.

2. *Middle Friars, Stafford*, throughout its entire length.

**SCHEDULE 3**

*(Waiting Limited to 1 hour in any 2, 8 a.m.-6 p.m. Monday-Friday)*

*Lengths of Road in the Borough of Stafford*

1. *Meyrick Road, Stafford*, on both sides from a point 15 metres east of its junction with Wolverhampton Road to a point 23 metres west of its junction with Salt Road.

**SCHEDULE 4**

*(Waiting Limited to 1 hour in any 2, 8 a.m.-6 p.m. Monday-Saturday)*

*Lengths of Road in the Borough of Stafford*

1. *Alexandra Road, Stafford*, on both sides from a point 15 metres east of its junction with Wolverhampton Road for a distance of 76 metres in an easterly direction.

2. *Friars Road, Stafford*, on its west side from a point 28 metres south of its junction with Newport Road for a distance of 109 metres in a southerly direction.

3. *Friars Terrace, Stafford*, on its east side from a point 13 metres south of its junction with Park Street for a distance of 27 metres in a southerly direction.
