## WAGES COUNCIL

### WAGES COUNCILS ACT 1959 EMPLOYMENT PROTECTION ACT 1975

#### *Retail Furnishing and Allied Trades Wages Council (Great Britain)*

The Retail Furnishing and Allied Trades Wages Council (Great Britain) hereby gives notice of proposals for (1) increasing the statutory minimum remuneration as set out in the Wages (Retail Furnishing and Allied Trades) Order 1976 (Order RFA (67)); and (2) the revocation of Order RFA (67). The Wages Council intends that the revised provisions shall come into operation on 7th November 1977.

Particulars of the proposals are contained in the Wages Council's Notice RFA (68), copies of which may be obtained on application to the Secretary of the Wages Council at the address given below. The Wages Council will consider any written representation with respect to the proposals if made within 21 days from 20th December 1977. It is desirable that persons making objections should state the precise nature of their objections and quote the number of the Wages Council's Notice of Proposals RFA (68).
