

by subsequent enactments, made a Representation to Her Majesty in Council that burials should be discontinued forthwith in St. Peter and St. Paul's Churchyard, in the said Parish, shown hatched on the plan annexed hereto. Provided that in any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons beretoany member of the family of the person or persons hereto-fore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

Now, therefore, Her Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 23rd day of March next. And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and

that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 23rd day of March.
