#### HIGHWAYS ACTS 1959 TO 1971

*North Devon Link Road (M5 Sampford Peverell-Tiverton (Bolham Road) and Slip Roads) Order 197*

The Secretary of State for Transport in pursuance of section 14 (9) of and Part IV of Schedule 1 to the Highways Act 1971 hereby gives notice that the period within which objections to the making of the above-named Orders may be made is hereby extended by 6 weeks to 14th March 1978.

### THE IMPORTED FOOD REGULATIONS 1968,

AS AMENDED

#### *Hungary: Official Certificate*

The Minister of Agriculture, Fisheries and Food gives notice that in exercise of the powers conferred on him by the Imported Food Regulations 1968 (S.I. 1968, No. 97) as amended by the Imported Food (Amendment) Regulations 1973 (S.I. 1973, No. 1351) he hereby restricts recognition of the Official Certificate reproduced in Part I of the Schedule to the notice published in the *London Gazette* dated 26th April 1968 for the importation of meat and meat products from Hungary, to the extent shown in the Schedule hereto.

The notice published in the *London Gazette* dated 30th September 1974 is hereby revoked.
