6. When an officer's reckonable service exceeds a given number of years (up to and including 33 years) by one or more complete days of a year, his retired pay will be increased by that number of days as a fraction of 365 of the difference between the rate for the number of years completed and the rate that would have been awarded had a further complete year been served.

Voluntary Retirement

7. An officer with at least 16 years' reckonable service who retires at his own request on or after reaching the age of 40 years and before reaching the age of 50 years, may be granted retired pay at the rates set out in Clauses 5 and 6 of this Schedule abated by 7½ per cent. Retired pay will be re-assessed at age 60 in accordance with Clause 2 of Schedule VIII. At other ages the retired pay will be as indicated in Clauses 5 and 6 of this Schedule.

An officer who has not served for at least 5 years after the grant of his permanent or pensionable commission will not be eligible for retired pay on voluntary retirement but may be awarded either a preserved pension in accordance with Schedule VII or any service pension or gratuity for which he may be eligible by virtue of service as a rating.

Service Invaliding Retired Pay

8. Officers serving on permanent and pensionable commissions who are non-attributably invalided on or after 1st April 1977 and who have completed at least five years' service of which at least two years have been served from the age of 21 years, may be awarded Service Invaliding Retired Pay at the following rates:
