TOWN AND COUNTRY PLANNING ACT 1971,
SECTION 211

The Secretary of State for Wales hereby gives notice that he has made an Order under section 211 of the Town and Country Planning Act 1971 to authorise the stopping up of lengths of Bathurst Street (between Clarence Terrace and Oystermouth Road), at Swansea in the County of West Glamorgan, to facilitate the movement of traffic on part of the West Perimeter Road which is a highway to be constructed in accordance with planning permission granted under Part III of that Act. The stopping up of lengths of Bathurst Street was originally part of proposals advertised on 4th August 1977.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 3rd March 1978 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
