**HIGHWAYS ACT 1959**

**COUNTRYSIDE ACT 1968**

*Wansdyke District Council (Footpaths at Stontobury Hill, Marksbury) Public Path Diversion Order 1978*

Notice is hereby given that on 17th March 1978, the Wansdyke District Council confirmed the above-named Order.

The effect of the Order as confirmed will be to divert a section of the public right of way BA 15/33 commencing 217 metres south-east from the main A.39 road at the junction of BA 9/15 and BA 15/33 crossing field O.S. No. 3374 for 424 metres, to a line commencing at the junctions of BA 9/15 and BA 15/33 south-west 98 metres south-east 262 metres and east for 205 metres to the existing path BA 15/33. To divert a further section of BA 15/33 from across field O.S. No. 5545 for 202 metres to around the boundary of field O.S. No. 5545 south-east 204 metres and south-west 46 metres to the existing path and to divert the final 314 metres of BA 15/33 from its junction with BA 15/8 across field O.S. No. 7726 to the main road to a line following the south-west boundary of field O.S. No. 7726 for 512 metres from the junction of BA 15/8 to the main road. To divert BA 15/8 from its junction with BA 15/33 north-east 324 metres across field No. 7726 to the Corston/Stanton Prior road to a line from the junction of BA 15/33 parallel with BA 15/8 north-east 166 metres and thereon 200 metres along the boundary of field No. 7349 to the Corston/ Stanton Prior road.

A copy of the Order as confirmed and the map contained in it has been deposited and may be inspected free of charge at the office of the Chief Executive and Clerk, Wansdyke District Council, Keynsham, Bristol between the hours of 8.30 a.m. and 4.30 p.m. Mondays to Fridays inclusive.

The Order became operative as from 17th March 1978, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Order, he may, under paragraph 2 of Schedule 2 to the Act as

applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 31st March 1978, make an application for the purpose to the High Court.

**HIGHWAYS ACT 1959—SECTION III**

**(COUNTRYSIDE ACT 1968)**

*Footpath No. 60 at Barnsley Public Path Diversion Order 1978*

Notice is hereby given that the above-named Order is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed as an unopposed Order, by the South Yorkshire County Council.

The effect of the Order, if confirmed without modifications will be to:

- (a) extinguish a section of path which is part of Barnsley Undefined Footpath No. 60 commencing at Point 'A' and proceeding in a generally north-north-westerly direction to Point 'B' for a distance of 275 yards;
- (b) and create an alternative footpath for use as a replacement for the footpath to be extinguished as at (a) above over land situate at Barnsley in the Barnsley Metropolitan District, commencing at Point 'A' and proceeding in a north-easterly direction to point 'C' for a distance of 65 yards and then in a generally north-westerly direction to Point 'B' for a distance of 260 yards.

Any representation or objection with respect to the Order may be sent in writing to the Chief Executive, County Hall, Barnsley no later than 30th April 1978, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the South Yorkshire County Council may, instead of submitting the Order to the Secretary of State for Environment for confirmation, themselves confirm the Order. If the Order is submitted to the Secretary of State for confirmation, any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
