Sides of Lengths of Roads in the District of Rhymney Valley

(i) Both sides of *Stuart Street*, Pontlottyn from its junction with *Merchant Street* (Route A.469) eastwards to its junction with *Picton Street*, a distance of approximately 50 metres (55 yards).

(ii) The south-western side of *Picton Street*, Pontlottyn, from its junction with *Station Street*, north-westwards to its junction with *Stuart Street*, a distance of approximately 38 metres (42 yards).

(iii) The south-western side of *Picton Street*, Pontlottyn, from the north-western corner of its junction with *Stuart Street*, north-westwards for a distance of 24 metres (26 yards).

(iv) The south-western side of *Picton Street*, Pontlottyn, from the north-western side of its junction with *School Street*, south-eastwards for a distance of 42 metres (46 yards).

(v) The north-eastern side of *Picton Street*, Pontlottyn, from a point 20 metres (22 yards) south-eastwards of a point opposite the south-eastern corner of its junction with *Stuart Street*, north-westwards to the southern side of its junction with *School Street*, a distance of approximately 146 metres (160 yards).

(vi) The northern side of *School Street*, Pontlottyn, from the north-western side of its junction with *Picton Street* eastwards to the eastern boundary of No. 2 *School Street*, a distance of approximately 40 metres (44 yards).

(vii) The northern side of *School Street*, Pontlottyn from the western side of its junction with *River Road*, westwards for a distance of 18 metres (20 yards).

(viii) The southern side of *School Street*, Pontlottyn, from the eastern side of its junction with *Picton Street*, eastwards to the eastern side of its junction with *River Road*, a distance of approximately 114 metres (125 yards).

(ix) The western side of *River Road*, Pontlottyn, from the northern side of its junction with *School Street*, northwards to its junction with *Route A.469*, near the *Rhymney River Bridge*, a distance of approximately 85 metres (93 yards).

(x) The eastern side of *River Road*, Pontlottyn, from its junction with *Route A.469*, near the *Rhymney River* southwards to the southern side of its junction with *School Street*, a distance of approximately 98 metres (107 yards).

(xi) Both sides of *Board Street*, Pontlottyn, from its junction with *River Road*, westwards for a distance of 10 metres (11 yards). (559)
