HIGHWAYS ACTS 1959 TO 1971

The Chester—Bangor Trunk Road (Milwr—Halkyn Road Junction Side Roads) Order 1978

The Secretary, of State for Wales hereby gives notice that, in relation to the above-mentioned Trunk Road at its junction with the Milwr—Halkyn Road at Milwr in the county of Clwyd he has made under section 9 of the Highways Act 1959 an Order, the effect of which is:

(a) to authorise him—

(i) to improve, raise, lower or otherwise alter Milwr Road;

(ii) to stop up the Milwr—Halkyn Road for about 6 metres southwards from its junction with the Trunk Road;

(iii) to construct a new highway about 33 metres in length to connect the Milwr—Halkyn Road with the Trunk Road;

(iv) to stop up the private means of access from the car park of the premises known as Calcot Arms to the Trunk Road for about 10 metres;

all at Milwr, near Holywell, Clwyd aforesaid, and

(b) to provide for the transfer of the said new highway to the County Council of Clwyd as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the Order and of the relevant plan have been deposited at the Welsh Office, Transport and Highways Group, Government Buildings, Ty-Glas Road, Llanishen, Cardiff, CF4 5PL, and at the offices of Clwyd County Council, Shire Hall, Mold, Clwyd, and of Delyn Borough Council, Civic Offices, Coleshill Street, Holywell, Clwyd, where they are to inspection free of charge at all reasonable hours.

The Swansea-Manchester Trunk Road (Pontardulais Road, Cadle, Swansea) Order 1978

The Secretary of State for Wales hereby gives notice that he has made an Order under Section 7 of the Highways Act 1959, in relation to the above mentioned Trunk Road at Cadle, Swansea in the County of West Glamorgan, the effect of which will be that the existing highway known as Pontardulais Road between its junction with Carmarthen Road (A4070) and the Swansea City Boundary shall become a trunk road as from the date when the Order comes into operation.
