## NOTICE OF PUBLIC PATH ORDER

*Diversion of Footpath No. 4 at Springmeadows in the Parish of Oddingley in the County of Hereford and Worcester.*

Notice is hereby given that the Secretary of State for the Environment in exercise of the powers conferred on him by section 209 of the Town and Country Planning Act 1971 and all other powers enabling him in that behalf, proposes to make an Order the effect of which will be to divert that part of Footpath No. 4 which runs from a point approximately 7.5 metres east of the eastern boundary of No. 86 Tagwell Road in a southerly direction for a distance of approximately 140 metres through Ordnance Survey Plots 1923 and 2515 on to a new line starting from a point approximately 6.5 metres east of the eastern boundary of No. 86 Tagwell Road and running in a southerly direction for approximately 51 metres, then crossing an estate road and following that estate road in a generally south-westerly direction for approximately 97 metres, and then in an easterly direction across Ordnance Survey Plot 2515 for approximately 52 metres to rejoin Footpath No. 4. The lines and situations of the existing and proposed alternative Footpath are shown on the map annexed to the draft Order.

A copy of the draft Order and the map contained in it has been deposited at the offices of the Wychavon District Council and may be inspected free of charge at the Council Offices, Norbury House, Friar Street, Droitwich during normal office hours.

Any representation or objection with respect to the draft Order may be sent in writing to the Secretary of State for the Environment (Ref: WMR/P/5249/151/9) Frieways House, Islington Row Middleway, Birmingham, B15 1SL, not later than 7th July 1978, and should state the grounds on which it is made.
