

Whereas by section 3 of the Naval and Marine Pay and Pensions Act 1865 (c. 73), it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Her Majesty's Naval or Marine Forces to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

And whereas it was expedient to increase the pay of Maltese Naval Locally Engaged Personnel by a flat rate of 60 cents per week from 15th October 1977, and it is now expedient for the increase to be reflected in pensions and gratuities paid to or in respect of such Personnel:

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her by the said Act and all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. This Order may be cited as the Naval and Marine Pay and Pensions (Maltese Locally Engaged Ratings' Service Pensions and Gratuities) Order 1978.

2. The rates of service pensions, terminal grants and service gratuities for Naval ratings locally engaged at Malta shall be as set out in the Schedules to this Order and shall have effect from the dates specified in the said Schedules.
