# THE NEWLAND MOSS AND THE RIVER DUDDON INTERNAL DRAINAGE DISTRICTS

Notice is hereby given that the Minister of Agriculture, Fisheries and Food, in exercise of the powers conferred upon him by sections 11(4) and 109(6) of the Land Drainage Act 1976, has now confirmed the North West Water Authority (Abolition of the Newland Moss and the River Duddon Internal Drainage Districts) Order 1978/843) made on 13th April 1978 to confirm the Scheme submitted to him under section 11 (1) of the Land Drainage Act 1976, making provision for the abolition of the Newland Moss and the River Duddon Internal Drainage Districts and the Internal Drainage Boards thereof.

A copy of the Order may be seen during normal office hours at the offices of the North West Water Authority, Dawson House, Great Sankey, Warrington, WA5 3LW, and at the offices of the Ministry of Agriculture, Fisheries and Food, Room 401, Great Westminster House, Horseferry Road, London, SW1P 2AE.

By paragraphs 10, 11 and 12 of Schedule 3 to the Land Drainage Act 1976, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with he may, within 6 weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.
