### Explanatory Note

These regulations prescribe the circumstances in which mobility allowance payable under section 37A of the Social Security Act 1975, as inserted in that Act by section 22 of the Social Security Pensions Act 1975, may be paid to someone other than the beneficiary where that beneficiary is provided with a vehicle under arrangements made by the charitable organisation known as Motability.
