SMOKE CONTROL ORDER No. 35**

Notice is hereby given that the Council of the London Borough of Hillingdon in exercise of the powers conferred on it by Section 11 of the above-mentioned Act on the 14th March 1978 made an Order entitled the London Borough of Hillingdon Smoke Control Order No. 35, declaring the area, described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will come into operation on 1 September 1978 or such later date as may be determined by the Secretary of State.

The prohibition of waiting proposals contain exemptions for vehicles being used in connection with a wedding or funeral or in pursuance of statutory powers or duties, and for emergency services vehicles. There are also exemptions for disabled persons' vehicles to wait for up to two hours and for vehicles loading and unloading goods to wait for up to twenty minutes in respect of the roads included in Item (b) except during the peak period loading ban.

Grove Walk/Grove Avenue Area
Proposed Waiting Restrictions

Notice is hereby given that:—

1. Norwich City Council propose to introduce a scheme of waiting restrictions in the Grove Walk/Grove Avenue Area to improve the amenity of the area and general safety for road users by the removal of parked cars.
2. The Council have considered a suggestion that a scheme previously advertised consisting of waiting restrictions at either end of Grove Walk, should be combined with 2 hour waiting restrictions, but decided against such a scheme because it was felt that there would be unacceptable difficulties of enforcement.
3. Therefore the following scheme of waiting restrictions is proposed:—
Waiting would be prohibited between the hours of 8 a.m. and 7 p.m. Mondays to Saturdays on the north side of Grove Avenue; the east side of Grove Walk; the south side of Eleanor Road to No. 16 and the north side of Lady Betty Road to its junction with St. Albans Road.
On the opposite sides of these roads and on the north side of Lady Betty Road from its junction with St. Albans Road to a point half way along the frontage of No. 148 Trafford Road, similar restrictions would be interrupted by a number of short lengths in which parking would be permitted.
4. Some minor alterations have been made to the scheme since the proposals were on view at the recent public meeting to take into account the suggestions made for parking at St. Albans Church and the Cecil Road end of Grove Walk.
5. There would be exceptions to the waiting restrictions to allow a vehicle to pick up or set down passengers and to load or unload goods, and for necessary waiting in connection with building operations, postal services and the maintenance of roads, mains and telephone services.
6. A copy of the draft Order, which would be known as "The City of Norwich (Grove Walk/Grove Avenue Area) (Prohibition of Waiting) Order 1978", together with a map, may be examined at my offices at City Hall during normal office hours.

5. Limiting waiting to a period not exceeding one hour on the north side of Bridge Street from a point 20 metres east of its junction with Studholmes Lane to a point 8 metres west of its junction with Bridge Lane.
6. Prohibiting waiting at any time on the south side of Caldcotes from a point 48 metres from its junction with Port Road to its junction with Wigton Road.
7. Prohibiting waiting at any time on the north side of Wigton Road from a point 100 metres east of its junction with Canal Street to its junction with Caldcotes.
8. Prohibiting waiting at any time on the south side of Wigton Road from its junction with Hawick Street to its junction with Church Street.
9. Prohibiting waiting at any time on the south side of Bridge Street from its junction with Church Street to its junction with Milbourne Street.
10. Prohibiting waiting at any time on both sides of Caldew Terrace (Shaddongate) for its whole length.
