## NOTICE OF CONFIRMATION OF PUBLIC PATH ORDERS

HIGHWAYS ACT 1959

COUNTRYSIDE ACT 1968

*Cleveland County Council (Footpath No. 1 Aislaby, Stockton-on-Tees) Public Path Diversion Order 1978*

*Cleveland County Council (Footpaths Nos. 2 and 3 Aislaby and Footpath No. 11 Eggescliffe, Stockton-on-Tees) Public Path Extinguishment Order 1978.*

*Cleveland County Council (Footpaths in the Parish of Aislaby, Stockton-on-Tees) Public Path Creation Order 1978.*

Notice is hereby given that on 30th June 1978 the County Council of Cleveland confirmed the above-named Orders.

The effect of the Orders as confirmed is as follows:

1. To divert Footpath No. 1 Aislaby running from Aislaby Road for a distance of 190 metres north-eastwards, to a line running along the northern boundary of Field No. 9965 for a distance of 140 metres to rejoin the existing route.

2. To extinguish:

(a) the length of Footpath No. 3 Aislaby running from Holme House Farm to its junction with Footpath No. 2;

(b) the length of Footpath No. 11 Eggescliffe running from Aislaby Road to Nelly Burdon's Beck;

(c) the length of Footpath No. 2 running from Nelly Burdon's Beck to a point on the river bank where the footpath turns south.

3. To create new Footpaths:

(a) from a point on Footpath No. 3 Aislaby approximately 120 metres south of Aislaby Road in a north/north-easterly direction for a distance of approximately 380 metres to its junction with Footpath No. 1;

(b) from a point on Footpath No. 3 approximately 300 metres south of Aislaby Road in a south-westerly direction for approximately 80 metres to its junction with Footpath No. 2.

Copies of the Orders as confirmed and the maps contained in them have been deposited and may be inspected during normal office hours at the offices of the County Secretary, Municipal Buildings, Middlesbrough, and the Borough Secretary, Municipal Buildings, Church Road, Stockton.

The Orders become operative on 30th July 1978, but if a person aggrieved by the Orders desires to question the validity thereof or of any provision contained therein on the grounds that they are not within the powers of the Highways Act 1959, as amended, or on the grounds that any requirement of that Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Orders he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 30th June 1978 make an application for the purpose to the High Court.

## PUBLIC PATH DIVERSION ORDER

HIGHWAYS ACT 1959

*Dacorum District Council (Footpath 23, Little Hay) Public Path Diversion Order 1978*

Notice is hereby given that the above-named Order made on 23rd June 1978 is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order, by the Dacorum District Council, Civic Centre, Marlowes, Hemel Hempstead in the County of Hertford.

The effect of the Order, if confirmed without modifications, will be to divert the public right of way running from a point 220 metres approximately from the junction of Hempstead Road and the road leading to the Clubhouse at Little Hay to the western side of the road leading to the Clubhouse a distance of 330 metres approximately after which it runs in a north-westerly and northern direction for a distance approximately of 160 metres and in a north-easterly direction for a distance of approximately 325 metres

thereafter it resumes a northerly and north-western direction for a distance of 435 metres approximately until it meets the boundaries of the golf course.

A copy of the Order and the map contained in it has been deposited and may be inspected, free of charge, at Dacorum Civic Centre, Marlowes, Hemel Hempstead, Herts. between 8.45 a.m. and 4.45 p.m. on Mondays to Thursdays inclusive and 8.45 a.m. to 4.45 p.m. on Fridays.

Any representation or objection with respect to the Order may be sent in writing to the District Secretary, Dacorum District Council at the address below before 7th August 1978 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Dacorum District Council may instead of submitting the Order to the Secretary of State for the Environment themselves confirm the Order. If the Order is submitted to the Secretary of State, any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
