## DEPARTMENT OF TRANSPORT

### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 209 of the above Act to authorise the stopping up of Russell Street, Windmill Lane and part of Queen Street, Rugby to enable development of the areas as a shopping complex to be carried out in accordance with planning permission granted to Chesterfield Properties Ltd. by Rugby Borough Council under Part III of the said Act.

The proposed Order will require the provision of a new footpath maintainable at the public expense, for which the highway authority is to be the Warwickshire County Council and part of which shall be subject to private vehicular rights.

During 28 days from 28th July 1978 copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Rugby Borough Council Offices, Town Hall, Rugby, and may be obtained free of charge from the Department of Transport (quoting WMRT 5077/41/3) at the address stated below.
