#### WATER RESOURCES (LICENCES) REGULATIONS 1965

##### *Notice of Proposal for the Variation of Section 23(4) of the South Devon Water Order 1950*

Notice is hereby given that the South West Water Authority have formulated proposals for the variation of Section 23 (4) of the South Devon Water Order 1950 to reduce the compensation water from the Avon Reservoir.

That Sub-section presently states "The prescribed quantity of compensation water to be discharged into the River Avon for the purpose of sub-section (2) of the said section 10 shall be one million, eight hundred thousand gallons." The said section 10 is section 10 of the 3rd Schedule of the Water Act 1945.

The Authority propose to pass a resolution to vary sub-section 23 (4) so that it reads "The prescribed quantity of compensation water to be discharged into the River Avon for the purposes of sub-section (2) of the said section 10 shall be one million, three hundred thousand gallons, subject to additional freshet releases being made as required by the Director of Fisheries and Recreation to the South West Water Authority up to the additional quantity stored in the Reservoir as a result of the reduction in compensation releases except when it can be shown that there is a danger of a serious deficiency in water supplies in the area served by the Reservoir."

Notice is hereby given that the Rochdale Borough Council in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956 on 20th June 1978 made an Order entitled the Metropolitan Borough of Rochdale (Former Borough of Middleton Completion) No. 5 Smoke Control Order 1977 declaring the area described in the Schedule hereto to be a smoke control area, which order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the exemptions provided by the Order and by virtue of Section 11(2) of the said Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

Copies of the Order and of the Map referred to therein may be inspected free of charge at the Town Hall, Rochdale at all reasonable times during the period of 6 weeks from 11th August 1978.

#### SCHEDULE

##### *Boundary of Area*

The area of land affected by the Order and shown on the map referred to therein is bounded by a line commencing at the point where the Borough of Rochdale boundary of the Metropolitan Borough of Oldham on Oldham Road, Middleton. The line bounding the area continues in a generally westerly direction along Oldham Road, Middleton to the junction of that road and Manchester New Road and then proceeds in a Northerly direction following the boundaries of the Borough of Middleton Nos. 16, 10A and 10B Smoke Control Orders where these pass along Burton Street and Rectory Street, Mellatieu Street and Wood Street to Hollin Lane and to a point on Langley Lane. The line takes in Hollins Drive and then continues in a Southerly direction to Abbey Road along the boundary of the area affected by the Borough of Middleton No. 8 Smoke Control Order. The line then proceeds in a generally Easterly direction along Abbey Road to Tintern Road and Whalley Road and then runs South along Furness Road to its junction with Hollin Lane. The line continues in a generally Easterly direction along Hollin Lane as far as the junction with Rochdale Road and then turns North East and continues along Rochdale Road. The line is drawn to the rear of the properties on Rochdale Road from Waverley Road to the junction of that road with the railway immediately before Slattocks Locks. The line continues in a Northerly direction along the railway embankment to the junction of the boundary of the former Borough of Middleton and the boundary of the former County Borough

of Rochdale. The line continues along the common part of the boundary between the Former Borough of Middleton and the former County Borough of Rochdale to the point where it meets the boundary of the Metropolitan Borough of Oldham. The line continues towards the South and the South West along the boundary between the Metropolitan Boroughs of Rochdale and Oldham until it reaches the railway line and bridge at Oldham Road, Middleton.

#### SCHEDULE

The Northern boundary commences at the intersection of Thornaby Road and Peel Street and is represented by a line drawn through the middle of Peel Street, travelling in an easterly direction. The boundary thereafter travels due south into Westbury Street and then passes into Langley Avenue, travelling due East again, until it intersects with Acklam Road (A174). Thereafter, the boundary travels due north in the centre of Acklam Road to the intersection of Acklam Road and Middlesbrough Road (A66).

The boundary then proceeds in a north-easterly direction down the centre of Middlesbrough Road, until it reaches the water-course of the "Old River Tees".

## KETTERING BOROUGH COUNCIL

*The Kettering Borough Council (Off Street Parking Places) Order 1978 No. 2*

- The Order reduced the excess charge from £6.00 to £3.00.
- The Charge in respect of quarterly season tickets remained unaltered.
- The Order provided that the part of the top floor of the Newborough Centre available for public parking at any time be redesignated a "Long Stay" Car Park.

Full details are contained in the Order, a copy of which may be seen in the Municipal Offices, Bowling Green Road, Kettering during normal office hours.

Any person who wishes to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order may, within 6 weeks of 20th July 1978, apply to the High Court for this purpose.
