A Proclamation

Appointing Monday, 1st January 1979 and Monday, 7th May 1979 as Bank Holidays in England, Wales and Northern Ireland and Tuesday, 26th December 1978 and Monday, 28th May 1979 as Bank Holidays in Scotland.

ELIZABETH R. MARGARET

Whereas Her Majesty, in pursuance of the Regency Acts 1937 to 1953, was pleased, by Letters Patent dated the 21st day of July 1978, to delegate to the six Counsellors of State therein named or any two or more of them full power and authority during the period of Her Majesty's absence from the United Kingdom to summon and hold on Her Majesty's behalf Her Privy Council and to approve and sign on Her Majesty's behalf any Proclamation relating to the affairs of the United Kingdom:

And Whereas Her Majesty considers it desirable that Monday, the first day of January and Monday, the seventh day of May in the year 1979 should be bank holidays in England, Wales and Northern Ireland and that Tuesday, the twenty-sixth day of December in the year 1978 and Monday, the twenty-eighth day of May in the year 1979 should be bank holidays in Scotland:

We, therefore, Elizabeth The Queen Mother and Margaret,

We, therefore, Elizabeth The Queen Mother and Margaret, Countess of Snowdon, being authorised thereto by the said Letters Patent and in pursuance of the powers conferred on Her Majesty by section 1(3) of the Banking and Financial Dealings Act 1971, do by and with the advice of Her Majesty's Privy Council on Her Majesty's behalf hereby appoint Monday, the first day of January and Monday, the seventh day of May in the year 1979 to be bank holidays in England, Wales and Northern Ireland and Tuesday, the twenty-sixth day of December in the year 1978 and Monday, the twenty-eighth day of May in the year 1979 to be bank holidays in Scotland.

Given at the Court of Saint James, this thirty-first day of July in the year of our Lord One thousand nine hundred and seventy-eight and in the twenty-seventh year of Her Majesty's Reign.
