Explanatory Note

These Regulations further amend the Social Security (Contributions) Regulations 1975 by providing for mariners employed on British ships to be treated as employed earners and, in relation to them, excludes the current provision that the person by whom the mariner's earnings are paid or the owner of the ship should have a place of business in Great Britain.

The Regulations revoke the transitional provisions relating to mariners (which are spent) and make new provision for the calculation of earnings related contributions payable by mariners in respect of a voyage period which falls partly in two or more tax years.

The Regulations also make provision as to the tax years

in respect of which contributions paid in respect of the voyage period, may be treated as paid.
