### ROAD TRAFFIC ACTS

#### CAMBRIDGE CITY COUNCIL

The City of Cambridge (Lion Yard) (Prohibition of Traffic) Order 1978

Notice is hereby given that the Cambridge City Council (hereinafter referred to as "the Council") pursuant to arrangements made under section 101 of the Local Gov-ernment Act 1972 with the Cambridgeshire County Council in exercise of the powers of the said County Council under sections 1 and 84D (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Local Government Act 1974 and of all other powers them enabling them in that behalf and with other powers them enabling them in that behalf and with the consent of the Secretary of State for Transport in accordance with section 84B of the Act of 1967 and after consultation with the Chief Officer of Police in accordance with section 84C (1) of the Act of 1967 made the above Order on 15th August 1978.

The effect of the Order, which comes into operation on 21st August 1978 is to prohibit all vehicles from proceeding at any time in Lion Yard.

The Order contains provisions permitting vehicles to be used for fire brigade or ambulance purposes or if the vehicle is being used in the service of the police of a local authority or a statutory undertaker in execution of their duties.

A copy of the Order may be inspected free of charge during normal working hours at the Guildhall (Room 6, first floor).

Any person wishing to question the validity of the Order or of any provision contained in the Order on the ground that it is not within the powers of the relevant section of the Act or on the ground that any requirements of that section or of sections 84A, 84B or 84C of the Act or any regulation made under the said section 84C have not been complied with in relation to the Order may within 6 weeks of the date on which the Order was made make applica-tion for the purpose to the High Court.
