Any person aggrieved by the Order and desiring to question the validity thereof or of any provision contained there-in, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 19th August 1978, apply to the High Court for the suspension or quashing of the Order or any provision contained therein.

Any person who, at the time of the coming into force of the Order, has an interest in land having lawful access to a highway to which the Order relates shall be entitled to be compensated by the South Glamorgan County Council as the local planning authority in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or damage which is so attributable.

The highways are at Cardiff in the county of South Glam-They are shown by zebra hatching on the deposited organ. plan and are:

- (a) that length of Queen Street which extends from its junction with Station Terrace/Dumfries Place to its junction with Park Place, a distance of 223 yards.
 (b) that length of the southern side of Queen Street which extends from its junction with Park Place to its junction with Charles Street for a width of 8 yards (c) that length of Churchill Way which extends from its

 (b) in accordance with a special authorisation for that use given by or on behalf of the South Glamorgan County Council or the Chief Officer of Police for the South Wales Constabulary;
- (c) for the purpose of conveying goods or merchandise to or from any premises situated on or adjacent to or only accessible from the said highways between the hours of 6 p.m. and 11 a.m. on any day;
 (d) on behalf of a statutory undertaker or the Post Office and accessible hours of the lowing creation main
- and engaged upon the laying, erection, inspection, maintenance, alteration, repair, renewal or removal or any sewer, or of any main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or of any telegraphic line as defined in the Telegraph Act 1878 under, in, on, over or across the highways or any land adjacent to the highways; and
- (e) where the vehicle is a disabled person's vehicle which displays a disabled person's badge issued by a local authority in accordance with the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or a badge having effect under those Regulations as if it were a disabled person's badge between the hours of 6 p.m. and 11 a.m. on any day.
