(ii) in a westerly direction for a distance of 46 metres, measured along the said lengths of road;

(b) south side, extending from the centre line of Hibbert Road Junction:

(i) in an easterly direction for a distance of 79 metres, and

(ii) in a westerly direction for a distance of 28 metres, measured along the said lengths of road.

2. *Barringer Road*, both sides, extending from Ravensdale Road junction in a northerly direction for a distance of 31 metres measured along the centre line of that road.

3. *Hibbert Road*, both sides, extending from Ravensdale Road junction in a southerly direction for a distance of 28 metres measured along the centre line of that road.
