

The effect of the Order as confirmed is to divert the public right of way running from A to B to a line running from A to C to D as shown on the map contained in the Order.

A copy of the Order as confirmed and the map contained in it has been deposited and may be inspected free of charge at the Legal Department, Room 50, Civic Offices, Swindon, Wiltshire, between 9 a.m. and 5 p.m. on Mondays to Fridays.

The Order becomes operative as from 1st October 1978, but if a person aggrieved by the Order desires to question the validity thereof or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Order, he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 4th October 1978, make an application for the purpose to the High Court.

The Tower Hamlets (Prescribed Routes) (No.) Traffic Order 197

Notice is hereby given that the Greater London Council propose to make the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The general effect of the Order would be to—

(a) impose one-way working for vehicular traffic in a general:

(i) north-easterly direction in the carriageway on the north-west side of the north-westernmost island site situated at the junction of Bethnal Green Road and Cambridge Heath Road;

(ii) south-westerly direction in the carriageway on the south-east side of the south-easternmost island site situated at the junction of Cambridge Heath Road and Roman Road;

(b) compel the left turn by vehicular traffic from the carriageway on the:

(i) north-west side of the island site referred to in sub-paragraph (a)(i) above; and

(ii) south-east side of the island site referred to in sub-paragraph (a)(ii) above

into Cambridge Heath Road;

(c) prohibit the left turn by vehicular traffic from the carriageway on the:

(i) south side of the island site referred to in sub-paragraph (a)(i) above into the carriageway on the east side of the said island site;

(ii) north side of the island site referred to in sub-paragraph (a)(ii) above into the carriageway on the west side of the said island site.

3. Exemption would be provided in the Order in respect of anything done:

(a) with the permission or at the direction of a police constable in uniform;

(b) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

4. A copy of the proposed Order and of the Council's statement of reasons for proposing to make the Order can be inspected during normal office hours on Mondays to Fridays inclusive until 24th October 1978, in Room B.21, The County Hall, London, SE1 7PB.
