The Trunk Road (Gilwern, Gwent) (Prohibition of Right Hand Turn) (No. 2) Order 1978

Notice is hereby given that the Secretary of State for Wales has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, which shall come into operation on 13th October 1978. The effect of the Order is that no person shall cause or permit any vehicle proceeding in a general easterly direction along that length of the Neath-Abergavenny Trunk Road (A.465) near Gilwern in the county of Gwent to make a right turn into the lane leading to Ty Gwyn at its junction with the said Trunk Road

which lies at a point 620 yards west of the Glanbaiden Roundabout.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks of 2nd October 1978 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
