PASTORAL MEASURE 1968

Notice is hereby given that HER MAJESTY was pleased on 24th October 1978 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the parishes of Owston and Withcote and declaring redundant the parish church of the parish of Withcote in the diocese of Leicester.
2. Uniting the benefices of Worminghall; Ickford; Oakley; and Shabbington, in the diocese of Oxford.
3. (1) Uniting the benefices of Bubwith; and Ellerton Priory with Aughton and East Cottingworth;
(2) Uniting the parishes of Bubwith; Ellerton Priory; and Aughton with East Cottingworth;
(3) Declaring redundant the parish church of the parish of Ellerton Priory;
- (4) Altering the areas of the parishes of Aughton with East Cottingworth; Thornton with Allerthorpe; and Sutton-on-Derwent; and
- (5) Altering the names of the benefice of Elvington and Sutton-on-Derwent and the parish of Sutton-on-Derwent, in the diocese of York.
4. Uniting the benefices and parishes of Saint Augustine with Saint Stephen, Haggerston; and Saint Mary with Saint Chad, Haggerston in the diocese of London, and declaring redundant the parish church of the parish of Saint Augustine with Saint Stephen, Haggerston.
5. Uniting the benefices of Henfield; Shermanbury; and Woodmancote, in the diocese of Chichester.
6. Providing for the appropriation of the redundant church of Saint Luke, Upper Lambourn, a former chapel of ease in the parish of Lambourn, in the diocese of Oxford, to use as a farrier's forge and for purposes ancillary thereto and empowering the said Commissioners to sell the building for such uses.
7. Empowering the said Commissioners to sell the site of the former parish church of the former parish of Christ Church, Durston, in the diocese of Durham, together with the land annexed or belonging thereto.
8. Uniting the benefices of Saint James, Sutton, Saint Edmund, Sutton; and Tydd Saint Mary, in the diocese of Lincoln.
9. Uniting the benefices of Much Birch with Little Birch; and Much Dewchurch with Llanwarne and Llandinabo, in the diocese of Hereford.
10. (1) Uniting the benefices of Hatton with Haseley; and Rowington,
(2) uniting the parishes of Hatton and Haseley, and
(3) altering the name of the parish of Rowington, in the diocese of Coventry.
