- 11. Uniting the benefices of Longdon; Bushley; and Queenhill and altering the name of the parish of Queenhill, in the diocese of Worcester.
- 12. Appropriating the redundant church of Saint Katherine, a former chapel of ease in the parish of Canvey Island, in the diocese of Chelmsford, to community use and for purposes ancillary thereto and empowering the Chelmsford Diocesan Board of Finance to lease the said building for such uses.
  - 13. (1) Creating new parishes of East Stour and West Stour,
  - (2) uniting the benefices of Gillingham and Fifehead Magdalen; Kington Magna and Buckhorn Weston; and Stour Provost with Todbere,

- (3) establishing a team ministery for the area of the new benefice, and
  (4) uniting the parishes of Stour Provost, East Stour and West Stour, in the diocese of Salisbury.
- 14. Appropriating the redundant church of Saint John, Athelhampton, a former chapel of ease in the parish of Athenampton, a former chaper of ease in the parish of Puddletown with Athelhampton and Burleston, in the diocese of Salisbury, and part of the land annexed or belonging thereto, to use as a monument and for purposes ancillery thereto, and empowering the said Commissioners to sell the said building and land for such use.
- 15. Providing for the Redundant Churches Fund to be responsible for the care and maintenance of the redundant parish church of the former parish of Harewood, and the land annexed or belonging thereto, in the diocese of Ripon.
- 16. Uniting the benefices and parishes of The Ascesion, Hulme; and Saint Mary, Hulme, Manchester, in the diocese of Manchester, and declaring redundant the parish church of the parish of Saint Mary, Hulme, Manchester.
- 17. Uniting the benefices and parishes of Old Swinford; and Saint John, Stourbridge, and altering the areas of the parishes of Amblecote; Saint John, Stourbridge; and Saint Thomas, Stourbridge, in the diocese of Worcester.
  - 18. (1) Terminating the team ministery established for the benefice of Pemberton;
    (2) creating a new benefice and parish of Saint Francis of Assisi, Kitt Green, Pemberton; and
    (3) altering the areas of the parishes of Pemberton; and Up Holland, in the diocese of Liverpool.
- 19. Uniting the benefices of Hook and Airmyn, in the diocese of Sheffield.
  - 20. (1) Revoking the provisions of an earlier Scheme, (2) appropriating the redundant parish church of the parish of Shenley, in the diocese of Saint Albans, and part of the land annexed or belonging thereto to use as a private chapel and for purposes ancillary thereto, and
  - (3) empowering the said Commissioners to sell the said building and land for such uses.
- 21. Appropriating the redundant parish church of the former parish of Braiseworth, in the diocese of Saint Edmundsbury and Ipswich, and the land annexed or belonging thereto, to use for residential purposes and for purposes ancillary thereto and empowering the said Commissioners to sell the said building and land for such uses.
- 22. Uniting the benefices of Bridgwater Saint John Baptist; and Chedzoy, in the diocese of Bath and Wells.
- 23. Appropriating the land annexed or belonging to the redundant church of Saint Simon, Bristol, in the diocese of Bristol, to use for purposes ancillery to the use of the redundant church, namely, for worship, services and other activities of a strictly religious nature in accordance with the rites and customs of the Greek Holy Orthodox Church, and empowering the said Commissioners to sell the said church and land for such uses.
- 24. Transferring the benefice of Chardstock, Saint Andrew and All Saints, and its constituent parishes, from the diocese of Salisbury to the diocese of Exeter.
  - 25. (1) Uniting the benefices of Barlings and Stainton by Langworth,
  - (2) transferring the parish of Sudbrooke from the benefice
  - of Sudbrooke with Scothern to the new benefice,
    (3) incorporating the extra-parochial place known Grange de Lings in the parish of Riseholme and alter-ing the name of the benefice and parish of Riseholme

to Riseholme and Grange de Lings,

(4) uniting the benefices of Dunholme; Riseholme and
Grange de Lings; and Sudbrooke with Scothern, in
the diocese of Lincoln.

- 26. Appropriating the redundant parish church of the former parish of Knapton, in the chocese of York, and the land annexed or belonging thereto, to use as a monument and for cultural and community purposes and for purposes ancillary thereto and empowering the York Diocesan Board of Finance to lease the said building and land for such uses.
- 27. Providing for the demolition of the redundant parish church of the parish Saint John, Fenwick, in the diocese of Sheffield, and appropriating its site to use as part of the burial ground annexed or belonging thereto.
- 28. Uniting the benefices of Coalbrookdale; Iron-Bridge; and Little Wenlock, in the diocese of Hereford.
- 29. Appropriating part of the churchyard of the parish church of the parish of Saint Peter and Saint Paul, Astonjuxta-Birmingham, in the diocese of Birmingham, to use by the parochial church-council of the said parish for ecclesi-astical purposes and vesting the said land in the Birmingham Diocesan Trustees Registered.
- 30. (1) Dissolving the benefice of West Hanningfield with South Hanningfield,
  - (2) creating a new benefice of West Hanningfield,
- (3) transferring the parish of South Hanningfield to the benefice of Downham,
- (4) altering the name of the benefice of Downham, and (5) altering the areas of the parishes of West Hanning-field; South Hanningfield; East Hanningfield; Downham; Stock Havard; and Saint Michael, Galleywood Common, in the diocese of Chelmsford.
- 31. Creating the new benefice and parish of West Slough out of parts of the parishes of Burnham; Farnham Royal; and Stoke Poges, in the diocese of Oxford and establishing a team ministry for the area of the new benefice.
- 32. Appropriating the redundant church of Saint Lawrence, Brentford, a former chapel of ease in the parish of Saint Paul, Brentford, with Saint Lawrence and Saint George, in the diocese of London, and the land annexed or belonging thereto, to use as a theatre and restaurant and to purposes ancillary thereto and empowering the London Diocesan Fund to lease the said building and land for such
- 33. Appropriating the redundant church of Saint Edward, King and Martyr, a former chapel of ease in the parish of Holbeck, in the diocese of Ripon, and the land annexed or belonging thereto, to use as an antique and fine arts store and for purposes ancillary thereto, and empowering the Ripon Diocesan Board of Finance to lease the said building and land for such uses.
- 34. Appropriating the redundant parish church of the parish of Brauncewell with Dunsby, in the diocese of Lincoln, and the land annexed or belonging thereto, to use as a monument and for purposes ancillary thereto, and empowering the Lincoln Diocesan Board of Finance to lease the said building and land for such uses.
- 35. Appropriating the redundant parish church of the arish of Colchester Saint Mary the Virgin (otherwise Saint Mary at the Walls), in the diocese of Chelmsford, and the land annexed or belonging thereto, to use for cultural and community purposes and for purposes ancillary thereto and empowering the Chelmsford Diocesan Board of Finance to lease the said building and land for such uses.
- 36. Establishing a group ministry for the area of the benefices of Saint Saviour, Brockley Hill; Saint Hilda with Saint Cyprian, Crofton Park; and Saint Augustine, Honor Oak Park, Forest Hill, in the diocese of Southwark.
- 37. Appropriating the redundant parish church of the former parish of Saint Martin, Edmonton, in the diocese of London, and the land annexed or belonging thereto, to use for worship, services and other activities of a religious nature in accordance with the rites and customs of the Greek Orthodox Church and empowering the said Commissioners to sell the said building and land for such uses.
- 38. Vesting a part of the churchyard of the parish church of the parish of Bromley, in the diocese of Rochester, in the Rochester Diocesan Society and Board of Finance (Incorporated) for disposal.
- 39. Revoking part of an earlier Scheme effecting the former parish church of Rishangles, in the diocese of Saint Edmundsbury and Ipswich, and appropriating the redundant building to use as a craft centre with residential accommoda-tion and for purposes ancillary thereto.
