- 2. The M25 Motorway (Poyle Interchange) Connecting Scheme 197, notice of which was published on 6th December 1977. This is a Scheme under sections 11, 12 and 14 of the Highways Act 1959 which, if made, will:
 - (a) authorise the Secretary of State for Transport to pro vide for the exclusive use of traffic of Classes I and II of the classes of traffic set out in Schedule 4 to the Highways Act 1959 (as amended) four special roads on routes described in the Scheme as means of entry to and exit from the north-bound and south-bound carriageways of the M25 Motorway at an interchange to be constructed with the Airport Spur Trunk Road at Horton Road in the said Borough and County; and (b) provide for the special roads to become trunk roads.
- 3. The Airport Spur Trunk Road (M25 Poyle Interchange 3. The Airport Spur Trunk Road (M25 Poyle Interchange to Heathrow) Order 197, notice of which was published on 22nd August 1978. This is an Order under sections 7 and 44 of the Highways Act 1959 which, if made, will provide that a new highway which the Secretary of State for Transport proposes to construct between Poyle and Heathrow in the said Borough and County shall become a trunk road.
- 4. The M25 Motorway (Yeoveney to Poyle Section Side Roads) Order 197, notice of which was published on 22nd August 1978. This is an Order under sections 13 and 18 of the Highways Act 1959, which, if made, will:
 - (i) authorise the Secretary of State for Transport
 - (a) to improve, raise, lower or otherwise alter highways, (b) to stop up highways,

 - (c) to construct new highways,
 (d) to stop up private means of access to premises, and
 (e) to provide new means of access to premises,
- all at Yeoveney or Poyle in the said Borough and County and
 - (ii) provide for the transfer of each new highway to the County Council of Surrey as from the date on which the Secretary of State for Transport notifies the Council that the new highway has been completed and is open for through traffic.
- 5. The Airport Spur Trunk Road (M25 Poyle Interchange to Heathrow Side Roads) Order 197, notice of which was published on 22nd August 1978. This is an Order under section 9 of the Highways Act 1959 which, if made, will:
 - (i) authorise the Secretary of State for Transport
 - (a) to improve, raise, lower or otherwise alter highways, (b) to stop up highways,
 - (b) to stop up highways,
 (c) to construct new highways and
 (d) to provide new means of access to premises, all at Poyle, Stanwell Moor or Heathrow in the said Borough and County, and
 (ii) provide for the transfer of each new highway to the County Council of Surrey as from the date on which the Secretary of State for Transport notifies the Council that the new highway has been completed and is open for through traffic for through traffic.
- 6. The M25 Motorway (Yeoveney to Poyle Section) and the Airport Spur Trunk Road (M25 Poyle Interchange to Heathrow) Compulsory Purchase Order (No. CSE) 197, notice of which was first published on 21st September 1978. This is an Order under sections 214 and 215 of the Highways Act 1959, sections 44 and 47 of the Highways Act 1971, section 22 of the Land Compensation Act 1973 and under section 1 of the Acquisition of Land (Authorisation Procedure) Act 1946, which if made will authorise the tion Procedure) Act 1946, which if made, will authorise the Secretary of State for Transport to purchase compulsorily the land and right described therein for the purpose of:
 - (a) the constuction of a special road between Yeoveney and Poyle in the said Borough and County in pursuance of the M25 Motorway (Runnymede Bridge to Yeoveney) Scheme 1977 and the M25 Motorway (Yeoveney to Poyle Section) Scheme 197;
 - (b) the construction of four special roads at Poyle in the said Borough and County in pursuance of the M25 Motorway (Poyle Interchange) Connecting Roads Scheme 197;
 - (c) the construction of a new trunk road from Poyle to Stanwell Moor Road (A3044) in the said Borough and County in pursuance of the Airport Spur Trunk Road (M25 Poyle Interchange to Heathrow) Order 197;
 - (d) the construction and improvement of highways and the provision of new means of access to premises at Yeoveney, Poyle, Stanwell Moor or Heathrw in the said Borough and County in pursuance of the M25 Motorway (Yeoveney to Poyle Section Side Roads) Order

197 and the Airport Spur Trunk Road (M25 Poyle Interchange to Heathrow Side Roads) Order 197;

(e) the diversion of a watercourse known as the Wravsbury River and the execution of other works on watercourses in the said Borough and County in connection with the construction of special roads, the construction of the trunk road, the construction and improvement of other highways and the execution of other works mentioned above;

(f) use by the Secretary of State in connection with such

execution of other works as aforesaid; and

(g) mitigating any adverse effect the existence or use of certain of the highways mentioned above will have on the surroundings thereof.

Proceedings on the above-mentioned draft Schemes and Orders are being taken concurrently by virtue of sections 14 (7) and 53 of the Highways Act 1971.
