TOWN AND COUNTRY PLANNING ACT 1971-SECTION 211

The Secretary of State for Wales hereby gives notice that he has made an Order under section 211 of the Town and Country Planning Act 1971 to authorise the stopping-up of the lengths and parts of highway specified in the Schedule to this notice to facilitate the movement of traffic on the Western Distributor Road which is a highway to be con-structed in accordance with planning permission granted under Part III of that Act. The Order requires the provision of a new highway

The Order requires the provision of a new highway maintainable at the public expense for which the highway authority is to be the Mid Glamorgan County Council. Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Welsh Office, Tran-sport and Highways Group, Government Buildings, Ty

Glas Road, Llanishen, Cardiff, CF4 5PL (quoting the reference WR15/5/81) and may be inspected at all reasonable hours at the offices of the Rhymney Valley District Council, Council Offices, Hengoed, and during normal library hours at the Public Library, Victoria Road, Rhymney.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 9th November 1978 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

All distances are approximate)

The lengths of highway to be stopped up are at Rhymney in the County of Mid Glamorgan and are:

- 1. That length of the unnamed road linking Robertson Row with the northern end of Brewery Row which extends from its junction with Robertson Row in a general westerly direction for a distance of 50 yards; and that length of Brewery Row which extends from its junction with the aforesaid unnamed road in a south-easterly direction for a maximum distance of 42 works direction for a maximum distance of 42 yards.
- 2. That length of the unnamed road linking Robertson Row with the Brewery which extends from its junction with Robertson Row in a south-westerly direction for a maximum distance of 60 yards; and that length of Brewery Row which extends from its junction with the said unnamed road in a north-westerly direction for a maximum distance of 17 yards.
