

## WEST SUSSEX COUNTY COUNCIL

*The County Council of West Sussex (Littlehampton: Various Roads) (Prohibition and Restriction of Waiting) Order 1978.*

Notice is hereby given that the West Sussex County Council propose to make an Order under the provisions of sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, the effect of which will be:

1. To alter the existing waiting restrictions, or to impose new restrictions so as to prohibit waiting at all times in short lengths of the following roads in Littlehampton: Terminus Place, East Street, High Street and Surrey Street.
2. To alter the existing waiting restrictions, or to impose new restrictions so as to limit waiting to one hour return prohibited within one hour between 8 a.m. and 6 p.m. in short lengths of Pier Road and High Street, Littlehampton.
3. To prohibit waiting at all times between 1st April and 30th September in The Martlets on both sides from its junction with Sea Road northwards for 20 metres.
4. To alter the existing waiting restrictions, or to impose new restrictions so as to prohibit waiting between 8 a.m. and 6 p.m. in East Street, Littlehampton, on the west side from a point 14 metres north of Church Street northwards for 54 metres, and revoke those lengths of restriction in Queen Street, Littlehampton, which prohibits waiting between 8 a.m. and 6 p.m.

A copy of the proposed Order, a plan showing the affected lengths of road, a statement of the County Council's reasons for proposing to make the Order and copies of the Orders to be revoked may be inspected at the County Hall, Chichester, during normal office hours and at the Public Library, Maltravers Street, Littlehampton, during normal library opening hours. Library staff will not be in a position to answer questions on the proposal and any inquiries should be addressed to the undersigned.

Objections to the proposal together with the grounds on which they are made must be sent in writing to the undersigned by 1st December 1978.

## TAUNTON DEANE BOROUGH COUNCIL

## AMENDED NOTICE

*The Taunton Deane Borough (Various Streets in Bishops Lydeard) (Prohibition of Waiting and Clearway) Order 1978.*

Notice is hereby given that Taunton Deane Borough Council propose making an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended, the effect of which will be as follows:

- (1) To prohibit waiting at any time in Bishops Lydeard—
  - (a) on both sides of Church Street from the junction with High Street southward for a distance of 25 yards;
  - (b) on both sides of High Street from the junction with Church Street northward for a distance of 25 yards;
  - (c) on the north side of West Street from the junction with High Street west-north-westward for a distance of 120 yards; and
  - (d) on the south side of West Street
    - (i) from the junction with High Street west-north-westward for a distance of 15 yards; and
    - (ii) from a point 42 yards west-north-west of the junction with High Street west-north-westward for a distance of 78 yards.
- (2) To make West Street, Bishops Lydeard a Clearway from a point 120 yards west-north-west of the junction with High Street to the junction with Watts Lane (a distance of 525 yards).

The Order in so far as it relates to the prohibition on waiting by vehicles contains the usual exemptions for vehicles being used for certain purposes including exemption for disabled persons' vehicles to wait for up to 2 hours.

The Order in so far as it relates to the Clearway will contain a more limited number of exemptions for vehicles

and waiting by disabled persons' vehicles will not be permitted.

Full details of the proposals are in the draft Order which, together with a map showing the lengths of roads concerned and a statement of the Council's reasons for proposing to make the Order, may be inspected at the Municipal Buildings, Taunton during the periods 8.30 a.m. to 12.45 p.m. and 1.45 p.m. to 4.30 p.m. Mondays to Fridays inclusive.

If you wish to object to the proposed Order you should send your objections in writing to the undersigned by 4th December 1978.

## TENDRING DISTRICT COUNCIL

*The Tendring District Council (Cambridge Road, Clacton) (Experimental One-Way Traffic) Order 1978.*

*The Borough of Thurrock (Leicester Road (Part), Tilbury) (Prohibition of Waiting) Order 1978*

Notice is hereby given that on 6th November 1978, the Thurrock Borough Council, pursuant to arrangements made under section 101 of the Local Government Act 1972, with the Essex County Council, in exercise of the powers of the said County Council under section 1 of the Road Traffic Regulation Act 1967, as amended, made the above-named Order.

This Order, which, with certain exceptions, makes it unlawful to leave your vehicle at any time in the length of road known as Leicester Road, Tilbury in the Borough of Thurrock (in the vicinity of the Jack Lobley County Primary School, including the entrance to the multi-storey car park) will come into operation on 13th November 1978.

A copy of the Order and a plan showing the restricted area to which the Order relates are available for inspection during normal office hours at the address given below.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from 6th November 1978, apply to the High Court for this purpose.
