  - (i) to enable vehicles being used for and in connection with the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road or the laying, erection, alteration or repair in or near the said road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878; or
  - (ii) to enable a vehicle; if it cannot conveniently be used for such purposes in any other road, to be used in pursuance of statutory powers or duties.
  - (iii) to enable goods to be loaded on or unloaded from a vehicle before 9.30 a.m. and after 4.30 p.m. on
  - (iv) for or in connection with building or demolition operations.
  - (v) for Police, Fire Brigade or Ambulance purposes.
- (3) To prohibit the making of right turning movements from West Street into Ashton Street.

- 7. To prohibit the waiting by vehicles between the hours of 8.00 a.m. and 7.00 p.m. throughout the year (excluding Sundays) for a longer period than 45 minutes in any 2 hours in the lengths of road specified in the Seventh Schedule here to;

In the Order are exceptions for persons boarding or alighting from vehicles, for the loading or unloading of goods and collection and delivery of postal packets, vehicles which are being used in connection with building operations, road maintenance and repairs and similar works, for wedding or funeral purposes and to enable vehicles to take in petrol, oil, water or air from any garage situate on or adjacent to any of the said lengths of road; there are also certain exemptions for disabled drivers.
