**NOTICE OF APPLICATION FOR AN EMERGENCY ORDER RELATING TO ABSTRACTIONS FROM THE RIVER YEALM AND ITS TRIBUTARIES**

Whereas in view of an exceptional shortage of rain a serious deficiency of supplies of water is threatened in the area of the South West Water Authority (hereinafter called "the Authority") which is served from the River Yealm Intake, the Broadall Lake and the Ford Brook in the Parish of Cornwood in the District of South Hams, within the Dartmoor National Park.

Notice is hereby given that in order to maintain an adequate supply of water, the Authority is applying to the Secretary of State for the Environment for an Order pursuant to Section 1 (3) (e) of the Drought Act 1976 to enable it for a period not exceeding 6 months to modify the conditions relating to the abstraction of water from the River Yealm by means of the River Yealm Intake at NGR SX 617620, the Broadall Lake at NGR SX 613620, and the Ford Brook at NGR SX 612618, as contained in Licence to Abstract Water Number 15/47/1/S/25, so as to provide that the residual flows immediately below the River Yealm Intake shall be reduced from 1.432 thousand cubic metres (0.315 million gallons) to 0.716 thousand cubic metres (0.158 million gallons); at the Broadall Lake from 0.623 thousand cubic metres (0.137 million gallons) to 0.311 thousand cubic metres (0.068 million gallons); and at the Ford Brook from 0.218 thousand cubic metres (0.048 million gallons) to 0.109 thousand cubic metres (0.024 million gallons) in any period of 24 hours.

A copy of the statement and plan illustrating the Authority's proposals may be inspected by any person, free of charge, at all reasonable office hours, at the office of the undersigned and at the office of the Authority, 6th Floor, Civic Centre, Plymouth, for the period of seven days from the date of publication of this Notice.

Objections to the application may be made to the Secretary of State for the Environment, 2 Marsham Street, London, SW1P (with a copy of the undersigned please) within seven days of the publication of this Notice.

- (b) Reduce the flow condition in order to allow abstraction when the flow as measured at Wadhams Farm Gauging Station (at National Grid Reference ST.055 268) exceeds 2.25 megalitres per day (2250 cubic metres per day or half a million gallons or thereabouts per day) at a maximum daily rate of abstraction of 17,300 cubic metres (17.3 megalitres or 3.8 million gallons per day).

The order will authorise the Authority to abstract water from the River Tone at Hele Bridge, in the Parish of Bradford-on-Tone, Taunton, Somerset, at Grid Reference ST.187 247 at the rate of 4,500 cubic metres per day (one million gallons per day) provided that the combined flow of the River Tone and the Halse Water as measured at Bishops Hull, Taunton (National Grid Reference ST.206 250) exceeds 0.52 cubic metres per second (9.9 million gallons per day).

Notice is hereby given that because of exceptional shortage of rain in the Somerset Division, the Wessex Water Authority ("the Authority") is applying to the Secretary of State for the Environment for an order under Section 1 of the Drought Act 1976.

The effect of the order would be to cancel the control conditions presently provided for under the existing licence (reference 16/52/7/123 dated the 1th April 1970) as subsequently varied on the 1st July 1977 and held by the British Waterways Board.

The order will provide that not withstanding the terms and conditions of the existing licence, in addition to the quantity of water which the Authority is entitled to take from the Bridgwater and Taunton Canal by virtue of an agreement dated 13th September 1971 made between the British Waterways Board and the West Somerset Water Board, and as varied by a supplemental agreement dated 25th October 1977 made between the British Waterways Board and the Authority, the Authority may, so long as the aggregate mean daily flow of water in the River Tone and the Halse Water as measured at their respective gauging stations at Bishops Hull is not less than any amount shown in column (1) of the following table, take from the said canal at National Grid reference point ST295366 in the Hamp Ward of Bridgwater, Somerset, a quantity of water not exceeding the quantity shown in column (2) of that table opposite to such amount:

### WEST GLAMORGAN COUNTY COUNCIL

*(Swansea Central Area) (Prohibition of Waiting, Loading and Unloading, Limited Waiting, One-Way Traffic and Revocation) Order 1978*

Notice is hereby given that on 17th November 1978 the West Glamorgan County Council made an Order in exercise of their powers under Section 1 (1), (2), (3) and 84 D(1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974 the effect of which is to:

5. To revoke the existing "No Entry" and "No Entry Except for Access" Restrictions in respect of Princess Street.
6. To revoke the existing southerly direction "One-Way Traffic" Order in respect of that length of Plymouth Street between Singleton Street and Oxford Street and to replace it with a "One-Way Traffic" Order operative in a northerly direction in respect of that length of Plymouth Street between the southern end of the Singleton Street 'Bus Station and its junction with Oxford Street.

Exemptions, where appropriate, will be provided in the Order for Loading/Unloading facilities, disabled drivers' vehicles and emergency services etc.

The Order will come into operation on 3rd December 1978 and may be cited as the "West Glamorgan County Council (Swansea Central Area) (Prohibition of Waiting, Loading and Unloading, Limited Waiting, One-Way Traffic and Revocation) Order, 1978".
