WAGES COUNCIL

EMPLOYMENT PROTECTION ACT 1975

Retail Furnishing and Allied Trades Wages Council (Great Britain)

The Retail Furnishing and Allied Trades Wages Council (Great Britain) hereby gives notice of proposals for: (1) increasing the statutory minimum remuneration and holidays and holiday remuneration as set out in the Wages (Retail Furnishing and Allied Trades) Order 1978 (Order RFA (69)); and (2) the revocation of Order RFA (69). The Wages Council intends that the revised provisions shall come into operation on 6th November 1978.

Particulars of the proposals are contained in the Wages Council's Notice RFA (70) copies of which may be obtained on application to the Secretary of the Wages Council at the address given below. The Wages Council will consider any written representation with respect to the proposals if made within 14 days from 24th November 1978. TOWN AND COUNTRY PLANNING ACT 1971
