Notice is hereby given that The Devon County Council propose to make orders under sections 1 (1), (2), (3) and (3b) and 84D (1) of the Road Traffic Regulation Act 1967 as amended, the effect of which will be:—

1. To prohibit the driving of motor vehicles and cycles in Laburnam Street from its junction with East Street for a distance of 3 metres in a southerly direction, at Torquay in the Borough of Torbay. This proposal will also include

the revocation of the existing one way traffic flow in Laburnum Street between its junction with East Street and its junction with St. Efrides Road.

2. To prohibit waiting at any time in East Street, north side, from its junction with Laburnum Row for a distance of 30 metres in a westerly direction, at Torquay in the Borough of Torbay.

3. To prohibit the driving of a vehicle into the "boxed area" on the carriageway of South Street, Torquay at or near its junction with East Street which will be marked by cross-hatched yellow lines bounded by a yellow line placed on the carriageway, unless the way is clear for such vehicle to proceed immediately out of the boxed area.

Exemptions in the order relating to (1) above will permit the driving of vehicles in that length of road in connection with building operations, road repairs, supply of gas, water and electricity, for emergency purposes or in the service of a local authority or statutory undertakers in pursuance of statutory powers or duties.

Exemptions in the order relating to (2) above will permit waiting for the purpose of boarding and alighting, loading or unloading, Post Office services, maintenance of the road, supply of gas, water and electricity, pursuance of statutory powers or duties, taking in petrol, oil or air from a garage. The statutory exemptions for disabled persons' vehicles are included.

Nothing in the order relating to (3) above will apply to anything done on the direction of a police constable in uniform or of a traffic warden or to a vehicle used for police, fire brigade or ambulance purposes, or to a vehicle, the driver of which when entering the boxed area had reasonable cause to believe that he would immediately be able to drive the vehicle out of that area.

**WEST YORKSHIRE METROPOLITAN COUNTY COUNCIL**

*The West Yorkshire Metropolitan County Council  
(Bradford) (Traffic Regulation) (No. 5) Order 1977*

*City of Norwich (Weston Road—Proposed Waiting  
Restrictions)*

Notice is hereby given that

1. Norwich City Council proposes to extend the waiting restrictions in Weston Road, to improve accessibility to the private entrances, and assist the free flow of traffic.

2. The waiting restrictions which would be brought into effect by a Traffic Regulation Order, would:—

(a) prohibit waiting at any time at and around the junction of Weston Road with its spur road, and for a short length of road covering the rear access to numbers 47-59 Woodcock Road;

(2) while postal packets are being collected for loading on the vehicle from premises or posting boxes adjacent to the bus lane or, having been so collected, are being loaded thereon to use the bus lane.

3. The general effect of the Islington (Waiting and Loading Restriction) (Amendment No. ) Order 197 would be further to amend the Islington (Waiting and Loading Restriction) Order 1976, so that the hours during which the existing prohibition applies —

(a) on waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be changed so that it would apply between 8 a.m. and 7 p.m. on Mondays to Fridays inclusive and between 8 a.m. and 6.30 p.m. on Saturdays in the length of street specified in Schedule 4 to this Notice;

(b) on waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle would be changed so that it would apply —

- (i) between 8 a.m. and 7 p.m. on Mondays to Fridays inclusive and between 8 a.m. and 6.30 p.m. on Saturdays in the length of street specified in Schedule 2 in this Notice;
