Notice is hereby given that the above-named Order, made on 17th November 1978, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed as an unopposed Order by the West

Devon District Council.

The effect of the Order, if confirmed without modifications, will be to divert part of the public right of way commencing at a point which lies some 200 yards up the Walla Brook from its confluence with the East Dart River to the south of the Clapper Bridge over the Brook near Babeny Farm in the Parish of Lydford in O.S. Plot No. 1984 (SX 6774) and proceeding firstly in an irregular north-north-westerly and north-easterly direction to the northern-most point of O.S. Plot No. 1984 keeping always north-north-westerly and north-easterly direction to the northern-most point of O.S. Plot No. 1984 keeping always to the west-most boundary of the said plot secondly in a north-north-westerly direction across O.S. Plot Nos. 2098 (SX 6774) and 2204 (SX 6775) keeping always to the western-most boundaries of those aforesaid plots thirdly entering O.S. Plot No. 1803 (SX 6775) at the point where it narrows to form a lane leading towards Babeny Farm fourthly passing northwards up that lane for a distance of approximately 50 yards to finally pass in a north-easterly direction across O.S. Plot No. 1514 (SX 5775) for a distance of some 100 yards reaching a point which lies some 50 yards to the east of Babeny Farm in the Parish of Lydford along the road running from Babeny Farm to the A.384 to a line running from the said point above referred to lying some 200 yards up the Walla Brook and proceeding firstly in a northerly direction within the Parish of Lydford along the western bank of the Walla Brook for a distance of some 40 yards to reach the Clapper Bridge connecting the Parishes of Lydford and Widecombe secondly crossing the Walla Brook by means of the Clapper Bridge and thirdly passing in an irregular north-easterly direction across the northern-most part of O.S.
