REVISED NOTICE

of making of a Noise Abatement Order under the Control of Pollution Act 1974

Notice is hereby given that the Gosport Borough Council, in exercise of the powers conferred upon them by Section 63 of the Control of Pollution Act 1974 on the 11th April 1978 made an Order entitled The Quay Lane (West) Industrial Estate Noise Abatement Order 1978, declaring the area described in the Schedule hereto to be a Noise Abatement Zone which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the Order and by virtue of Sections 63, 64, 65, 66 and 67 of the said Act, if noise emitted from any premises constitutes a contravention of Sub-Section (1) of Section 65 or of a condition attached to a consent under this Section, the person responsible shall be guilty of an offence against Part III of the said Act and is liable on summary conviction to a fine of £200 in the case of a first offence and £400 in the case of a second or subsequent offence against this part of the Act. Section 65, Sub-Section (1) provides that the level of noise recorded in the Noise Level Register in respect of any premises is not to be exceeded except with the consent in writing of the Local Authority., Section 66 Sub-Section (1) enable the Local Authority to serve a Noise Reduction Notice on the person responsible for noise emanating from premises within a Noise Abatement Area when it appears to the Authority that the level of noise is not acceptable and that a reduction is practicable at reasonable cost and would afford a public benefit. Sub-Section (8) of that Section provides that a person who without reasonable excuse contravenes a Noise Reduction Notice is to be guilty of an offence against Part III of the said Act.

- (l) on the north west side of Station Road from its junction with Portsmouth Road north eastwards for a distance of 60 metres.
- (m) for a distance of 18 metres on the south east side of Station Road at its junction with Portsmouth Road.
- (n) for a distance of 15 metres on both sides of The Grove at its junction with Portsmouth Road.
- (o) for short lengths on both sides of the service road to Numbers 384 to 398 Portsmouth Road at its junction with Portsmouth Road.
- (p) for a distance of 45 metres on the north western side of Weston Lane at its junction with Portsmouth Road.
- (q) for a distance of 20 metres on the south east side of Weston Lane at its junction with Portsmouth Road.
- (r) on both sides of Wrights Hill from its junction with Portsmouth Road south eastwards for a distance of 95 metres.
- (s) for a distance of 15 metres on both sides of West Road at its junction with Portsmouth Road.

2. To limit waiting to Thirty minutes 8 a.m.-6 p.m. Monday to Saturday on the south east side of Station Road from a point 18 metres north east of its junction with Portsmouth Road north eastwards for a distance of 30 metres.
