Yorkshire Dales Light Railway

1. To authorise the British Railways Board and the Company to enter into and carry into effect agreements providing for the transfer to the Company of the railway on such terms and conditions as may be agreed between the Board and the Company.

2. To provide for the transfer to the Company of the rights, powers, privileges and obligations of the British Railways Board in respect of the railway.

3. To authorise the Company to work the railway as a light railway under the principal Act.—12th December 1978.

South-west side, from a point 13.20 metres north-west of its junction with Sandgate Road north-westward to a point 7.62 metres south-east of its junction with Bouverie Road West.

Castle Hill Avenue (Eastern carriageway)

North-east side from the centre line of Bouverie Road West south-eastwards for a distance of 40 metres.

Castle Hill Avenue (Eastern carriageway)

North-east side, from a point 75 metres south-east of the centre line of Bouverie Road West south-eastwards to its junction with Sandgate Road.

Bouverie Road West

North-west side, from a point 3 metres north-east of Castle Hill Passage, south-westwards to its junction with Castle Hill Avenue.

Bouverie Road West

South-east side, from a point 3 metres south-west of its junction with Christ Church Road north-eastwards to a point 35.72 metres north-east of its junction with Manor Road.

3. To revoke the existing restriction of waiting (1 hour in any 3 hours, 8 a.m. to 6 p.m., Mondays to Saturdays inclusive) in the following length of road:

Bouverie Road West

South east side from a point 27.43 metres north-eastwards of its junction with Castle Hill Avenue north-eastwards to a point 7.31 metres south-west of its junction with Christ Church Road.

4. To restrict waiting to 1 hour in any 3 hours between 8 a.m. and 6 p.m. on Mondays to Saturdays inclusive in the following lengths of road:

Bouverie Road West

South east side from a point 27.43 metres north-east of its junction with Castle Hill Avenue north-eastwards to a point 3 metres south-west of its junction with Christ Church Road.

Bouverie Road West

North-west side from a point 3 metres north east of its junction with Castle Hill Passage north-eastward to a point 7.5 metres south-west of its junction with Christ Church Road.

5. To revoke the existing one-way traffic flows in the following lengths of road:

Bouverie Road West from its junction with Castle Hill Avenue to its junction with Manor Road—West to east.

Castle Hill Avenue (both legs) from its junction with Sandgate Road to its junction with Bouverie Road West—South to north.

Christ Church Road from its junction with Bouverie Road West to its junction with Sandgate Road—North-west to south-west.

Manor Road from its junction with Bouverie Road West to its junction with Sandgate Road—North to south.

Sandgate Road from its junction with Manor Road to its junction with Castle Hill Avenue—North-east to south-west.

6. To introduce one-way traffic flows as follows in the following lengths of road:

Castle Hill Avenue (western carriageway) from its junction with Sandgate Road to its junction with Bouverie Road West—South to north.

Castle Hill Avenue (eastern carriageway) from its junction with Bouverie Road West to its junction with Sandgate Road—North to south.

Christ Church Road from its junction with Sandgate Road to its junction with Bouverie Road West—South to north.

Manor Road from its junction with Bouverie Road West to a point 50 metres north of its junction with Sandgate Road—South to north.

The alternative route being A25 Newlands Corner to Clandon Crossroads, A246 to Merrow. The availability of this route makes it appropriate to exclude entirely these vehicles from Trodds Lane, except for the purposes mentioned above, in order to end the congestion and occasional hazards caused by such use.

HARINGEY LONDON BOROUGH COUNCIL

*The London Borough of Haringey (Prescribed Route)
(No.1) Experimental Traffic Order 1978*

1. Notice is hereby given that the Council of the London Borough of Haringey, pursuant to arrangements made with the Greater London Council, on 13th December 1978 made the above mentioned Order under the powers of the Greater London Council conferred by Section 9 of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The general effect of the Order will be to prohibit vehicular traffic from entering or leaving Stainby Road at its junction with High Cross Road.
