The Trunk Road (Builth Wells, Powys) (Prohibition and Restriction of Waiting) (Variation) Order 197

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 1 and 84D(1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968. The effect of the Order will be to vary the Trunk Roads (Builth Wells, Powys) (Prohibition and Restriction of Waiting) Order 1976. The effect of this variation shall be to prohibit waiting on the length of trunk road specified in the Schedule to this Notice. At the moment waiting is limited to 30 to this Notice. At the moment waiting is limited to 30 minutes no return with 30 minutes between the hours of 8 a.m. and 6 p.m., Mondays to Saturdays, on this length of road.

Exceptions are provided in this Order to allow a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic and the maintenance of the road or the services thereon; or to enable the vehicle to be used in the service of a local authority or of a water authority in pursuance of statutory

powers or duties.

Exceptions are also provided in the Order to allow vehicles bearing both a disabled person's badge and a parking disc to wait on the side of road specified in the Schedule to this Order for a period not exceeding 2 hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of road).
