#### NOTICE OF APPLICATION TO VARY LICENCES TO ABSTRACT WATER

Notice is hereby given that an application is being made to the Severn Trent Water Authority by James Heath & Sons Ltd. of Bolas House, Great Bolas, Telford, to vary the following licences: 18/54/4/965 to abstract water from the River Tern at Map Reference SJ 646220; 18/54/4/966 to abstract water from the Allford Brook at Map Reference SJ 667228 and SJ 658223; 18/54/4/967 to abstract water from the River Meese at Map Reference SJ 654209.
