Whereas a Representation duly made to Her Majesty in Council by the Secretary of State for the Environment that burials should be discontinued as hereinafter directed in St. Mary the Virgin and All Souls Churchyard, Bulwell, in the County of Nottinghamshire, has, in pursuance of an Order in Council made the 29th September 1978 and duly published, been taken into consideration by a Committee of the Privy Council:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section 1 of the Burial Act 1853(a), and of all other powers Her enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:-

1. Burials shall be discontinued forthwith in St. Mary the Virgin and All Souls Churchyard, Bulwell, in the


County of Nottinghamshire, shown hatched on the plan annexed hereto.

Provided that-

- (a) in any vault or walled grave now existing in the said Churchyard, burial may be allowed subject to the con-dition that every coffin buried in such vault or grave be separately enclosed by stone-work or brickwork properly cemented;
- (b) in any earthen grave now existing in the said Church-yard, the burial may be allowed of the body of any member of the family of the person or persons here-tofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.
- 2. This Order may be cited as the Burial Grounds (St. Mary the Virgin and All Souls Churchyard, Bulwell, Notinghamshire) Order 1978.

Whereas the Secretary of State for the Environment, after giving to the Incumbent and Churchwardens of the Parish of St. John Evangelist, Lynsack, in the County of Durham, ten days' previous notice of his intention in that behalf has, under the provisions of the Burial Act 1853 as amended by subsequent enactments, made a Representation to Her Majesty in Council that burials should be discontinued forthwith in the Churchyard of St. John Evangelist, in the said Parish, shown hatched on the plan annexed hereto.

Provided that-

(a) in any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons here-tofore buried in such grave, subject to the condition that no part of the coffin containing the body shall

be at a depth less than three feet below the level of the surface of the ground adjoining the grave;

(b) in the said Churchyard, in the one grave;

(b) in the said Churchyard, in the one grave space in which no interment has heretofore taken place, the burial may be allowed of the body of any person for whom or of any member of a family for which such grave space has been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjainfeet below the level of the surface of the ground adjoin-

row, therefore, her Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 21st day of February next.

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 21st day of February.
