Notice is hereby given that on 10th January 1979 the Stroud District Council made the above-named Order which is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Stroud District Council as an unopposed Order.

The effect of the Order if confirmed without modification will be to:

- (a) Extinguish that length of Public Footpath Number MST.30 in the parish of Stonehouse from its junction with Copner Close at Ordnance Survey grid reference SO 80729/05741 to a point 117 metres north-west thereof at Ordnance Survey grid reference SO 80650/05828.
- (b) Create an alternative highway over a two metre wide strip of land from Copner Close at Ordnance Survey grid reference SO 80729/05741 extending north-eastwards for 34 metres to Ordnance Survey grid reference SO 80744/05771 and then north-westwards for 111 metres to joint Public Footpath MST.30 at Ordnance Survey grid reference SO 80650/05828.
