EXTINGUISHMENT OF PUBLIC RIGHTS OF WAY

*The Basildon Development Corporation Langdon Hills  
Housing Area*

Notice is hereby given that the Secretary of State for the Environment in exercise of his powers under section 23 of the New Towns Act 1965, has made an Order extinguishing as from the date of the Order, the Public Rights of Way over those parts of highways shown coloured blue and blue hatched red on the map referred to therein.

- (a) that part of Butler's Grove starting from its junction with High Road, Langdon Hills and extending in a westerly direction for a distance of approximately 170 feet, then in a northerly direction for a distance of approximately 120 feet and then in a westerly direction for a distance of approximately 135 feet.
- (b) that part of a public footpath formerly connecting the eastern and western parts of Butler's Grove, commencing at a point 185 feet to the west of High Road, Langdon Hills and extending in a westerly direction for a distance of approximately 130 feet.
- (c) that part of a public footpath starting from its junction with High Road, Langdon Hills at a point approximately 110 feet to the south of the eastern end of Butler's Grove and extending in a westerly direction for a distance of approximately 310 feet.

Notice is hereby given that the above Order (hereinafter referred to as "the Order") made on 2nd January 1979 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Borough Council of Hinckley and Bosworth as an unopposed Order.

Any representation or objection with respect to the Order may be sent in writing to the Secretary at the Borough Council of Hinckley and Bosworth, Council Offices, Argents Mead, Hinckley, not later than 28 days from the date of publication of this notice and should state the grounds on which it is made. If no representations or objections are duly made or if any so made are withdrawn the Borough Council of Hinckley and Bosworth may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order.

If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

Notice is hereby given that on 11th January 1979 the Lewes District Council confirmed the above-named Order.
