(b) Vehicles may not wait at any time and for the purpose of loading and unloading between 8 a.m.-9.30 a.m. and 4 p.m.-6 p.m. Monday to Saturday on A472 Clarence Road (part length), A472 Albion Road (part length), A4043 Clarence Street, A4043 Hanbury Road (part length), A4043 Commercial Street, A4043 Park Road, Commercial Street and George Street (part length).

(c) Vehicles may not wait during 8 a.m. to 6 p.m. Monday to Saturday on part lengths of Osborne Road, George Street, Crane Street and Market Street.

(d) Vehicles may not wait during 8 a.m.-6 p.m. Monday to Saturday and for the purposes of loading and unloading between 8 a.m.-9.30 a.m. and 4 p.m.-6 p.m. Monday to Saturday on A4043 Hanbury Road (part length).

Exceptions will be included in the Order to permit waiting for the purpose of

- (a) picking up and setting down passengers;
- (b) loading or unloading goods or merchandise (unless otherwise specifically stated);
- (c) delivery or collection of postal packets;
- (d) the maintenance of the roads;
- (e) the supply of gas, water and electricity and of any telegraphic line;
- (f) the pursuance of statutory powers or duties;
- (g) a funeral; and
- (h) disabled person's vehicle (for a limited period).

(ii) Trosnant Street (part length) and Upper Trosnant Street (Prohibition of driving except for Access) Order 1979.

Vehicles may not proceed in Trosnant Street (part length) and Upper Trosnant Street. Exceptions

will be included in the Order for the purposes of Access to the adjoining properties.

- (iii) Commercial Street (Prohibition of Left Hand Turn) Order 1979.

Vehicles proceeding southwards along Commercial Street shall not turn left into A4043 Park Road.

- (iv) Crane Street (part length), Market Street, Trosnant Street (part length), Upper Trosnant Street and Lower Bridge Street (part length) One Way Traffic Order 1979.

Vehicles may only proceed in the specified direction on the following roads:—

- (a) Crane Street (part length)—North east to South west.
- (b) Market Street—North east to South west.
- (c) Trosnant Street (part length)—North west to South east.
- (d) Upper Trosnant Street—East to West.
- (e) Lower Bridge Street (part length)—East to West.

- (v) A4043 Park Road and A472 Clarence Road (Prohibition of Right Hand Turn) Order 1979.
